The Public Hearing for proposed Distillery of capacity 150.0 KLPD to produce Rectified Spirit/Extra Neutral Alcohol/Ethanol Based on Sugar Cane Juice/Syrup/" C"/"B" Heavy Molasses/Grains proposed by Project Proponent M/s Malhar Sakhar Karkhana Ltd., Gat No.174 & 175, Village-Chandapuri, Tal – Malshiras, Dist -Solapur, Maharashtra was conducted on Tuesday, the 05<sup>th</sup> October, 2021 at the site of the said industry at 12.30 a.m.

District Collector, Solapur approved the date of public hearing on Tuesday, the 05th October, 2021 and as per the Notification dated 14-09-2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, GoI), New Delhi and subsequent amendment on 01-12-2019, Member Secretary, Maharashtra Pollution Control Board, Mumbai has constituted Public Hearing Panel vide Board's Office Order No. E- 85 of 2021 under letter no. BO/JD (WPC)/PH/B- 210930-FTS-0129, , dated 30th September, 2021:-

Shri Ajit Vasantrao Patil, Sub Regional Officer, MPCB, Solapur, Member, Convener of the Environment Public Hearing Committee welcomed Ms. Shama Pawar, Additional District Magistrate, Solapur and Chairman of the Environment Public Hearing Committee; Environmentalists, NGOs, Journalists and Company Officials and local people/participants who were present and informed that as per the Environment Impact Assessment Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, GoI) dated 14<sup>th</sup> September, 2006 as amended on 1<sup>st</sup> December, 2009, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification.

Member, Convener of the Public Hearing Committee welcomed all and informed that the meeting is called in the prevailing situation of Covid-19 pandemic. Hence, it is requested all the participants to follow strict guidelines as issued by Govt. of India and Govt. of Maharashtra from time to time. As per the guidelines, only 100 persons/participants are allowed in a session. If the participants are more, then remaining will be allowed in next session. The sessions will continue till all the participants are given opportunity to attend the meeting. The thermal checking and use of sanitizer is kept at the entrance of the pandol and now it is compulsory to wear a mask and follow the social distancing amongst the persons in the meeting hall. He informed that Maharashtra Pollution Control Board was in receipt of application from Project Proponent M/s Malhar Sakhar Karkhana Ltd., Gat No.174 & 175, Village-Chandapuri, Tal – Malshiras, Dist - Solapur, Maharashtra for their proposed Distillery of capacity 150.0 KLPD to produce Rectified Spirit/Extra Neutral Alcohol/Ethanol Based on Sugar Cane Juice/Syrup/" C"/"B" Heavy Molasses/Grains.

The Convener further informed that as per EIA Notification, 2006 the category of project falls under Category A 5 (g), which requires to obtain prior Environmental Clearance from the Environment, Forest and Climate Change Department, Govt of India, New Delhi for which prior environmental consultation is mandatory. Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing and they should know the developmental activities and Environment Management Plan of the unit.

Project Proponent had submitted online prescribed application on 08-05-2021 alongwith pre-feasibility report to Environment, Forest & Climate Change, Govt. of India, New Delhi for Terms of Reference (TOR) for conduct of EIA studies and it has been considered and given online approval on 11-05-2021. As per said Notification, 30 days' advance public notice was published by Sub Regional Office, MPCB Solapur in the Local Newspaper in Daily Sanchar for Marathi and in National Newspaper daily The Indian for English on 05<sup>th</sup> September, 2021. The public were appealed to send their suggestions, views, doubts or objections regarding the proposed unit.

Also copy of EIA report and executive summery were made available at various notified offices of Government i.e. Ministry of Environment, Forest & Climate Change, Zonal Office, West Central Zone, New Secretariat Building, Ground Floor, East Wing, Civil Line, Nagpur-440 001; District Magistrate Office, Solapur; Additional District Magistrate Office, Solapur; Chief Executive Officer, Zilla Parishad Office, Solapur; General Manager, District Industries Centre Office, Solapur; Tahsildar, Tahsil Office-Malshiras, Tal-Malshiras, Dist – Solapur; Gram Sevak/Sarpanch, Gram Panchayat Office, Mouje – Chandapuri / Nimgaon / Khudus / Kusmod / Zanjewadi / Goradwadi/Tarangfal/Garvad, Tal-Malshiras, Dist – Solapur; Sub Regional Office, MPCB, Solapur; Regional Office, MPCB, Pune and at Head Office of MPCB at Mumbai, Environment & Climate Change Department, Govt. of Maharashtra, New Administrative Building, Mumbai and on the website of MPCB. The public in general were appealed to send any suggestion or objection regarding the proposed new distillery project.

Convener informed that participants can raise their views, suggestions/objections for the proposed expansion of the project in environmental angle only orally as well as in writing also.

Convener requested Chairman of the Public Hearing Committee to start the proceedings.

With the permission of Chairman, Project Environment Consultant gave geographical location of the proposed unit, proposed impact on the environment due to proposed project and details of Environment Management Plan of the proposed

unit. Environment Consultant informed that Project Proponent has ear-marked capital cost of Rupees 40.8 Crores and for maintenance of pollution control devices Rupees 305.0 lakhs.

After presentation, participants were appealed to raise their views, suggestions or objections.

Member, Convener, Environment Public Hearing Committee appealed all to raise their suggestions or objections in respect of proposed project in environmental angle only briefly. While informing the views, first name and name of village/residence should be informed.

After presentations, Environment Public Hearing Committee appealed the participants to raise their views, suggestions or objections regarding propose plant in environmental angle only.

Shri Deepak Maruti Kopnar Water Supply Employee, Grampanchayat Chandapuri, informed that complaints, objections have been received by the Grampanchayat Office -Chandapuri from various local people, local farmers regarding the proposed project i.e. commissioning of new distillery plant (M/s Malhar Sugar). For this, I have brought letter from Panchayat Samiti. Shri Kopnar has read the application sent by Panchayat Samiti to Sub Regional Office, MPCB, Solapur. While reading he informed that it is informed to Sub Regional Officer, MPCB, Solapur that commissioning of M/s Malhar Sakhar Karkhana Ltd., Gut No.174 and 175, Chandapuri, Tal-Malshiras, Dist -Solapur is proposed. In this context, complaints from local farmers and damage to the vineyard, sugarcane crops, also damage to the agriculture fields should be thought seriously.

Secondly, this is to inform that the installation of the plant is proposed at Gut no.174 and 175, Chandapuri, Tal — Malshiras, Dist-Solapur. Adjacent to the proposed plant site, Grampanchayat Chandapuri has submitted a proposal for new water supply plan i.e. Chief Minister Drinking Water Plan (मुख्यमंत्री पेयजल योजना) i.e. Mukhyamantri Peya Jal Plan), which is already approved. Hence, all the above letters, complaints, present status should be considered

Grampanchayat Chandapuri for all points has given letter vide no.89/2021-22 dated 05-10-2021 to the Committee. The respective application alongwith other objections will sent collectively to the Expert Committee, who takes decision.

While giving answer on behalf Project of Proponent, Environment Consultant said that many of these issues have been clarified during the presentation. It is already informed that this project is ZLD i.e. Zero Liquid Discharge. The Project Environment Consultant informed that pollution control devices will installed and its summary is briefly described as follows -

Member, Convener of the Environment Public Hearing Committee here informed that 13 participants have raised their suggestions, objections.

The 8 suggestions/objections received are enclosed herewith enclosed as annexure. Attendance sheet of 31 participants is enclosed as annexure.

Member, Convener of the Environment Public Hearing Committee informed that written applications and its reading is done by 07 people and 06 people have raised oral suggestions/objections. He directed Environment Consultant to give answer on the points of suggestions/objections.

Environment Consultant while giving answers informed that all the points have already been explained while giving the presentation. She informed that this project is ZLD i.e. Zero Liquid Discharge. The treated effluent which will be produced during the manufacturing activities will be recycled and reused in the process. Govt. of India has Not a drop of water will go outside the factory.

The Government of India has laid the condition to all the distilleries that not a single drop of water/treated effluent would flow outside the project

It is informed by Project Consultant that as this is private factory, all the family members can be on the panel of Board of Directors. The answer for how many days the distillery unit will be in operation is given that after obtaining MPCB permission, normally within two years the plant will be in operation. The question regarding job opportunities to local people is given that local people will be given priority for job opportunities.

At this moment, some participants while raising the objections informed that we have given 11 acres of land to the project. We are not allowed to enter in the factory site. Then how we can believe that they will give job opportunities to local people? The question was raised that whether raw material ie. grains will be purchased from Malshiras. It is answered that if project management get the raw material from near area, naturally the cost of the factory will be saved and the profit will be made. It will be benefit to local people also. It is answered that rate for sugarcane crop will as per market price.

The participants have raised doubts that this factory, like other factories, would cause pollution. The answer is given that each factory is different.

Most of the participants have informed that they oppose the factory. One participant informed that he has spent 40 lakhs for the development of vineyard and

sugarcane crop. It is totally wasted due to pollution. We have given land for free of cost for setting up a sugar factory.

The Environmental Consultant while giving information about the written objections, stated all the names and their objections and the damage done to the grape and sugarcane crop.

Most of the participants were of the view/opinion that let us allow to cultivate our fields, we do not want the project. They have also remarked that when one project is in operation, we do not want another.

Most of the local farmers objected that we have given our land for the sugar factory and not to distillery unit. They said that since last 22 years, we have given our land for the factory. One is in operation. Now we do not want another. aldn for We have given our land since last 2.2. Morever, it was decided that our land will be return back to us. The answer to the question raised by Shri Nitin Londhe is given that the requirement of manpower in the plant is about 90.

Member, Convener, Environment Public Hearing Committee informed that all the views/suggestions or objections raised by the participants are noted. The minutes of the meeting, the suggestions/objections received and Final Environment Impact Assessment report will be submitted to Environment, Forest & Climate Change Department, Govt. of India, New Delhi. An Expert Committee of MoEF & CC will take further necessary action.

Member, Convener Environment Public Hearing Committee here informed that if local persons demands, the video recording and copy of the minutes of the meeting will be made available to them.

At this moment, most of the participants informed that if an attempt is made to inaugurate the project by hurting our feelings. We all have taped the total proceedings/discussions of the meeting.

While concluding the meeting, Chairperson of the Environment Public Hearing Committee remarked that it is already informed by Member, Convener of the meeting that the suggestions or objections raised during the meeting by the participants are noted and total video recording is carried. This is public hearing. Just as factory management through their environment consultant has presented their views, so also

the local people have expressed their views, suggestions and also objections. We heard both sides. It is already informed by the Member, Convener of the meeting that in this meeting no decision is taken. This meeting is called to convey your views regarding the proposed project in environmental angle to Govt. of India. The procedure of the public hearing is completed. The final decision is taken by the Government. Chairperson, Environment Public Hearing Committee declared that this meeting is concluded.
