Project Proponent M/s Mohda Crusher Owners' Association, At Village – Mohda, Tal – Wani, Dist – Yavatmal, Maharashtra, has applied to Ministry of Environment, Forest & Climate Change, Govt. of India New Delhi for permission of carrying out the study in the radius of 10 k.m. of project and preparation of Environment Impact Assessment (EIA) Report for obtaining Environmental Clearance for the Proposed Mining Project Cluster For Stone Quarries Total Extent In The Cluster Total Area 99.99 H.A.(Cluster Area 67.58 H.A.) and for Total Mines - 69 at Village Mohda, Tal. Wani, Dist. Yavatmal, Maharashtra.

An Expert Committee at Ministry of Environment, Forest & Climate Change, Govt. of India New Delhi has approved the ToR on 07-01-2021. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing and to include in the final environmental impact assessment report the environmental issues raised by the project affected people about the proposed project. As the proposed project falls under S. No.1 (a) Mining of Minerals under Category B, it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from Ministry of Environment, Forest & Climate Change, Govt. of India New Delhi.

Project Proponent M/s Mohda Crusher Owners' Association, At Vill. Mohda, Tal. Wani, Dist. Yavatmal, Maharashtra has applied Maharashtra Pollution Control Board on 25/04/2022 for conducting Environment Public Hearing. District Collector, Yavatmal, Maharashtra State, in co-ordination with MPCB Chandrapur Office, approved to hold a public hearing on 13-07-2022. It is directed to conduct the Online public hearing. The meeting number and password was made available.

#### Minutes of the Environment Public Hearing:-

At the beginning of the meeting, Shri. Atul Satfale, Sub-Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener, Environment Public Hearing Committee welcomed Shri. Lalitkumar Warhade, Additional District Magistrate, Yavatmal and Chairman, Environment Public Hearing Committee; Shri. A. M. Kare, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member, Environment Public Hearing Committee, Tahsildar, Tal. Wani, Dist. Yavatmal, District Mining Officer, Yavatmal District Collector Office, Yavatmal, Project officials, Journalists, NGOs working in the

field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized only for the local people and project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of Chairman of the Environment Public Hearing Committee, Convener asked Environment Consultant to give presentation of Environment Management Plan of the proposed project.

Project Consultant informed regarding expansion of the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting:-

- Impact and management of air, water, displacement, biodiversity due to planned project
- Information on environmental management after project implementation
- Information on other environmental management

After the Presentation, Convener appealed to the participants to raise their environmental suggestions or objections about the proposed project. While raising questions, inform the full name, village. He also informed Project Environment Consultant and Project Proponent to give appropriate answers.

My parents are suffering a lot due to dust of the crushers and are undergoing treatment in hospitals and medicines.	Answers / Assurances given by the Project Proponent / Environment Consultant / Public Hearing Committee following the discussions  The Environmental Consultant informed that the public hearing, which is going on, is for the cluster. Environmental Clearance (EC) for stone quarries gets in two stages. The first Cluster will be granted EC. The reason for forming Association of stone quarries is that a small miner cannot afford it, because he has small pockets. The Central Government informed to form an Association of all mines and implement a big programmed which would be done
	through clusters.

Besides this, each individual mine has to obtain EC. So, here the first Cluster will get EC and then individual mine will get EC. The Association will have CSR and CER. 2.5 percent profit and CER will be separated. Most advanced Air Pollution Control (APC) system will be installed in the project.

Here, the Convener, Environmental Public Hearing Committee, appealed to participants to state their name and village clearly while raising their suggestions or objections orally.

## 3) Shri. Nagesh Vitthal Junnari, Vill. Krishnapur, Tal Wani, Dist. Yavatmal:-

## 4) Shri. Sachin Wasikar, Dy.Sarpanch, Mohda Gram Panchayat, Tal. Wani, Dist. Yavatmal:-

1) It has been 32 years since 1989 at Mohda. In the last 32 years, around 400 crore funds have been received from Mohda village and 10% of it i.e. 40 crore rupees has been deposited with the Government. Until we get that Rupees 40/- Crore, no new proposal should be approved. In this, the terms and conditions of the Government have been followed. A total of 19 farmers' statements have been received by Mohda Gram Panchayat. They should be given a compensation of Rs 50,000 per hectare.

Government is getting funds because of the growth that is happening Mohda. in Gram panchayats need to get funds from it for health, education. As the Deputy Sarpanch of Mohda Gram Panchayat, Mohda is requesting you not to approve any new proposal until the funds are available.

Environmental Consultant said that this subject of 10% is related to Government. Mine Owners and association continue to pay DMF on royalty.

### 5) Shri. Khalil Shaikh, Vill. Mohda, Tal. Wani, Dist. Yavatmal:-

Sr. Question / Suggestion / Objection No.

1)

I have a request to the Crusher Association that they should supply murum, stones and other necessary materials for the roads where agriculture fields are adjacent to the crushers.

Because many roads are broken due to yesterday's rain. If the local farmers demand murum or other commodities, the crushers usually refuse to supply. However, I request that they should repair the roads. This is a heartfelt request to you.

Answers / Assurances given by the Project Proponent / Environment Consultant / Public Hearing Committee following the discussions

The Environmental Consultant opined

that there is no objection. He asked the President of the Association to reply. Shri. Rajurkar, President, Mohda Stone Crusher Association said that questions have been raised regarding the road next to the farm. Even in the past, when the farmers, the Sarpanch's of the respective village demanded to put murum on the Panand road, at that time, the Mine Owners have provided and spread the murum. So, the question of making available the murum secondary. In future, when required, it will surely be made available

demand. The Environmental Consultant said that the Project Proponent has
given an assurance in this regard. At this time, some of the participants protested that it was never given. The participants demanded that the proof should be given if it was given. Shri. Rajurkar said that it has been made available where the local administration asked for it. If you want clarification about this, the local administration will
clarify it.  This time, when the participant gave a negative reaction, the Environmental Consultant said that this is why the Association has been established a all the statutory rules can be followed.

1)	There is a lot of traffic in this area. Three normal accidents took place on the road from Wani to Mohda.	Suggestion is noted.

One woman died and two youths are in hospital.

Now, these accidents have happened due to the wrong way of injecting the murum. There are potholes on the road, but the overloaded trucks in this mine have made the potholes worse.

He further objected that the dust from this mine falls on our crops and cotton fields, which are surrounding the project. Due to this, the cotton turns black and we suffer huge loss per hectare.

When our farmers go to the crusher owners to ask for compensation, they are chased away. Although the crusher is allowed by the Mohda Gram Panchayat and Government, the dust causes huge losses to the local farmers. Similarly, these crushers are playing with the health of the local people. Here, in the morning, if water is covered in any earthen pot or steel pot, next day it is observed a layer of dust is formed on it. That layer is caused by explosives in the mine, mixed with water. There was no water in Mohda before ten years. Now it is there because of water in the mines. The Gram Panchayat tank was empty. People's health is bad because of water and pollution. This situation is due to these mines. People do not get clean water.

That water is gunpowder containing. They get water to drink. Anganwadi-1 and Anganwadi-2 and Asha workers have figures that how many children are born as malnourished, disabled due to this pollution. In Mohda, Keshavnagar and at nearby villages, all this is happening due to this pollution.

Provision has been made for providing drinking water facilities in the villages. Reverse Osmosis (R.O.) system is proposed by the Association.

3)	Also, here we have children, old people. They should not have an accident due to these roads. Roads in between were built, but the main roads were closed. Do not know who's this question belongs? Here is the basic concept like Vijubhau or Ashish Bhau said that this public hearing is going on, this is going on for the cluster. Environmental Clearance for stone quarries gets in two stages. The Cluster will be granted EC first. The reason for taking it is that a small mine owner cannot afford it, because he has small pockets. The central government directed to form an association of all and implement a big programme which would be done through clusters. Besides, each individual mine has to obtain Environmental Clearance. So here the first one will come from the cluster and the second one will be from the individual mine. CSR and CER are only of Associates. 2.5 percent profit and CER will be different. If you see the District Survey Report, it is mentioned in it. Each mine will be different. There is complete information about it on the website of District Mining Officer, District Collector, Yavatmal. CSR and CER of each project promoter will be different.

3) Shri. Nagesh Vithal Junnari -

Dust comes in the field and smells After the explosion there is a smell there are small mines here. So for proper co-ordination, this cluster proposal has been prepared and the public hearing method has been adopted. Many miners do different types of blasting. Here Control Delay Blasting will be done by Association.

It will be implemented by the association and will be binding on the mine owner who is a member of the cluster. A Regulatory Procedure will be implemented by the Association. It will also be a condition for each mine owner's Individual Environment Clearance.

- Shri. Sachin Wasikar, Deputy Sarpanch, Mohda Project Consultant informed that 10% is related to Government and associations continue to pay DMF on royalty.
- 5) Shri. Khalil Shaik, Mohda demanded for murum and stones. Environmnt Consultant remarked that there should not be any objection for this demand. He appealed President, Association to answer the same.

Shri. Rajurkar said that questions have been asked about the road next to the farm. Even in the past, when the farmers, the sarpanchs of that village

demanded to put murum on the Panand road, at that time the mine owners have provided and spread the murum.

So the question of getting rid of murum is secondary. In future, when required, it will surely be made available on demand. The environmental consultant said that the project promoter has given an assurance in this regard.

At this time, some of the participants complained that it was never given. The participants demanded that the proof should be given if it was given. At that time, Mr. Rajurkar said that it has been dumped where the local administration asked to dump it. If you want clarification about this, the local administration will clarify it. This time, when the participants gave a negative reaction, the environmental consultant said that the association has been established for this purpose and all the statutory rules can be followed.

Shri. Kishore Sankawar, - Project Consultant informed that Provision has been made for drinking water in the village. R.O. Water provision is

proposed to be done by Association.

Shri. Vidhate online question was about Mines closure. According to the Maharashtra Government notification dated January 12, 2018, the mines of minor minerals should be converted into ponds for water storage. Such measures should be taken. Similarly, the final mining closure plan should be approved by the [Director, Geology Mining]. Actions should be taken and the report should be submitted to the District Mining Officer. The gut no.. 75 is a government gat number. There is no actual involvement of the mines owner. Where there are mineral mines, the final closure plan will be approved by [Director, Geology Mining]. He said that where there is a Final Closure Plan/Final Mining Closure Plan, by creating a water sump. The mining closure plan will be approved by the [Director, Geology Mining].

Shri. Vidhate has raised the issue of fishing. So, we thought while planning that there is a big government closed mine. So, fishing system can be adopted there. Here fishing training is considered, and provision is made for it. This expenditure can be made from the CER fund of each mine. Shri. Phulsunge demanded that We give a Niveda/statement to the Hon. Collector here. If nothing happens in eight days, we will start agitation, till then all quarries should be closed. Mines should be started only after the roads are repaired.

Shri. Vidhate, who was present online at this time, objected and said that this public hearing is a government one. It is going on under the chairmanship of the Hon. Collector. There is no provision for agitation in the Environmental Impact Assessment Notification.

However, the concerned officer should withdraw the word protesting or agitation. Convener, Environmental Public Hearing told Shri. Vidhate who was present online and everyone in the meeting that the words that they have to protest were not uttered by the environmental committee or the government officials present.

The meeting is a dialogue between the local people present, the Environmental Consultant and the Project Proponent i.e. President, Mohda Dagdakhan Collective Association. Convener asked the project promoters to withdraw the word protest. Mr. Rajurkar President, Mohda Dagdakhan Collective Organization withdrew the word to protest.

The Environmental Consultant said that a question was raised about job opportunities to local people. So, in the proposed project 1600 persons can get employment, out of which 200 persons will be from skilled cadre. Mr. Phulsange asked how many jobs are you going to provide and how many people are currently working in the project?

The Project Promoter stated that 40% of the working project is skilled and 60% unskilled. Shri. Phulsange asked to give the figures of how many skilled and unskilled employees there are.

The project promoter said that 350-400 are unskilled, while around 125-150 are skilled labour. Mr. Phulsange further asked how many of these are local people from Mohda and how many from the Tundra? After the project promoter replied that 70-80 Mohda workers started shouting in the meeting that the local people are not doing a single job.

At this time, the Chairman, Environment Public Hearing Committee instructed the project promoters to make available to each Gram Panchayat the name wise and village wise list of working workers, local and external.

At that time, after the discussion, the Chairman, Environmental Public Hearing Committee instructed the project promoters to provide a separate list of the number of unskilled, semi-skilled, skilled cadre posts in the project and the classification of the proposed appointments to all Gram Panchayat offices.

Shri. Phulsange demanded that the character certificate of the workers of other district and other state should be taken and the information should be reported to the concerned police station here. Because there is no such report of the workers in any of these mines in the local/concerned police station.

Chairman, Environmental Public Hearing Committee welcomed the relevant suggestion and said that the said suggestion is right and suggested the project promoters to implement it immediately. The project promoter agreed to

the suggestion and promised to take further action in this regard.

Environmental Consultant informed that suggestions were made to us for training the local people. Vocational Training Center which is DGMS can conduct training in co-ordination with it. Association will definitely take initiative in this regard. Mr. Phulsange asked how many days it would take to decide the policy. The environmental consultant said it would take at least four months.

The next question was that after making a complaint to MPCB, the concerned complainants are not informed about the inspection report and

further action. MPCB should give an answer in this regard.

The Environment Consultant, while replying to the written objections of Mr. Vijubhau Pidurkar, said that the total area is 99.99 hectares and the cluster area is 67.58 hectares. There are some closed mines. As per the notification dated July 1, 2016 by the Ministry of Environment, Forests and Climate Change, Government of India, New Delhi, the areas of closed mines and those granted environmental clearance till July 1, 2016 should not be included in the cluster. Therefore, the difference in area is visible and will remain.

Responding to Mr. Pidurkar regarding the discrepancies in the figures, the Environmental Advisor said that just as each mine has an individual mining

plan, the cluster also has a regional mining plan.

A mining plan approved by the Director, Geology (Mines) will be made available. He said that if there are any discrepancies in EIA and elsewhere, they will be rectified properly. At this time, Chairman, Environment Public Hearing Committee directed to make the changes in the report to the project promoters and environmental consultants, it should be made like that the general public can understand it.

Shri. Pidurkar objected that in the EIA each capital is shown separately. Answering about the capital, the environmental consultant said that the capital investment for the cluster is the Environmental Management Plan (EMP), but the budget for collective responsibility will fall to the Association.

The Environmental Consultant said there were no rules for minor minerals. Now it is in existence. Every mining DSR – District Survey Report is

important. The mineral policy of the district is based on this. He explained the policies regarding CER.

He said that if the capital investment is less, they are prescribed a certain amount. Accordingly, the responsibility of planting 7,500 trees will be with the Association. But after obtaining individual environmental clearance, the responsibility for planting trees at a distance of 7.5 meters or at other places will remain with those mine owners.

After Shri. Pidurkar raised objections regarding tree plantation, the Environmental Consultant replied that out of the four mines which are closed, three are government mines, so the association cannot do anything about it.

Shri. Pidurkar object that so far only the information about how many trees have been planted on these mines and their width and height should be given. According to the instructions of the environmental consultant, trees of 2-4 years and their height should be kept only 5-6 feet. Here we are only talking about clusters.

Shri. Pidurkar objected again and said that whether you are going to guarantee the survival of 7,500 trees? The environmental consultant replied that the tree planting rate in stone quarries is 70%. Here, 7,500 trees will have 70% survival and 30% will have to be planted each year.

Similarly, we are going to plant trees along the road. Also, we will plant in

public places, dams, because the survival rate of trees there is low.

Shri. Pidurkar suggested to provide a statistical list of trees in existing mines and closed (closed and functioning) mines. The project promoter replied

that a list certified by the Forest Department would be provided.

Shri. Ajay Pandurang Dhobe, District President, Sambhaji Brigade, Yavatmal Dist. Yavatmal inquired that Mohda villagers had complained to Mpcb on 02-11-2018 regarding air pollution in working mine. MPCB had conducted a survey in this regard on 24-01-2019. Thereafter, Sub-Regional Officer, MPCB Chandrapur issued instructions to each mine on 4-2-2019, whether it been fulfilled?

Convener, Environmental Public Hearing Committee said that the

relevant survey and subsequent action will be reported in this regard.

At this time Mr. Ajay Pandurang Dhobey suggested that until the report of 4-2-2019 is received from MPCB, this public hearing should be postponed, because if those instructions are still not fulfilled, then how will it be done now? Convener, organizer said that your suggestion has been noted.

The environmental consultant admitted the mistake and said that it is per acre and not per hectare. Mr. Pidurkar made a statement to the Environment Public Hearing Committee that the EIA report should be prepared according to the scientific and scientific approach of the government in relation to agriculture.

Chairman, Environment Public Hearing Committee directed to rectify the discrepancies.

Shri. Pidurkar demanded that the local youth should be given the training needed for machineries in the mining industry. There is no mention in the EIA about on-the-job training.

Shri. Pidurkar suggested clarification regarding CSR. At that time, the Environmental Consultant said that CSR can be determined only after 2% of

each mine is profited, considering the cluster here, CSR said.

Shri. Pidurkar questioned the mining officials whether a list of 5 km was prepared according to the new policy and whether Mohda's name was included in it. According to the notification amended from time to time under the Mining Rules, 1957 by Govt. of India, the District Collector is Chairman of the Mining Fund Allocation Committee. Whether according to the Central and State Government Notification of 2019, 5 km villages are listed?

Chairman, Environment Public Hearing Committee replied on behalf of the District Collector said that all the notifications presented by Shri. Pidurkar, as per the government decision, five km. list of remote villages will be provided to you in written form. For that you should submit your written application to the

Mining Authorities.

On this occasion, Mr. Pidurkar expressed his opinion that there should be a big library and gymnasium here. Here the return of royalty is NIL. We can make Mohda village even next to Singapore. However, if Chairman gives an explanation about the non-availability of funds, we will get justice.

Chairman, Environment Public Hearing Committee here promised that whatever there are DMF Rules, District Mining Officer (DMO) will look into the matter personally and it is directed to DMO to initiate further action.

#### 19) Shri. Waman Madavi, Vill. Mohda, Tal. Wani, Dist. Yavatmal:-

He raised the issue of not getting the pending money of thirty thousand rupees. The concerned cluster member promised to give the concerned person the pending money within eight days. Shri. Madavi said I am a local and I don't have a simple house. But those who came from outside area and State are getting houses built. Chairman said that the issue of Gram Panchayat should not be raised here.

Shri. Phulsange said that the Project Proponent said that they had provided the Murum. However, on this 4th of July, there has been a protest for road repair in Tundra. He has not provided the murum of one vehicle/small truck also to the villages. So, we are repeatedly talking about this issue, if not done so far, then what will be done in the future? However, we demand that this public hearing be postponed for four months. It should be taken back after four months only after fulfilling everything.

## 20) Shri. Vijay Maruti Thavari, Sarpanch Tundra Gram Panchayat, Tal. Wani, Dist. Yavatmal:-

1)	We had protested for the road on 4th July. The school bus does not come. Overloaded trucks pass through bad roads. Due to this, accidents have increased. Convener asked the Project Proponent to provide information on the removal of murum.	The Project Proponent said that for the Tundra-Mohda road, a discussion with Deputy Engineer, Wani is held four days ago. They demanded us Murum, and they are ready to provide the machinery. So Muram in this regard will be made available and further action will be taken in 1-2 days.  Chairman here remarked that promise made by the Project Proponent to provide Murum, then he is instructed to complete all the process within eight days.

Shri. Ravindra Pusate, Vill. Mohda, Taluka Wani, District Yavatmal demanded Chairman that there are local people, Collectors and mine owners. So now we will go to the mine and check how many trees are planted. Chairman, Environment Public Hearing Committee said that the project promoters have been ordered to submit a report.

Chairman, Environment Public Hearing Committee asked Project Consultant to give answers again to Online Participant Shri. Vidhate.

Environmental Consultant replied that as per Central Government Notification dated January 2018, it is directed to make water storage arrangement/pond during mine closure for minor minerals. Accordingly, the closure plan has to be submitted to the Director, Geology (Mines) and the mine will be closed under the supervision of his District Mining Department.

Environmental Consultant replied that the amount indicated for fishing training would be paid from the CSR of the association. But the CSR of every mining owner will be different. There is no need to get any objection certificate from Wildlife Board. 5,700 trees are proposed annually for green belt development. Safety Zone is 200 meters as per Maharashtra Mining Act. There is no provision for 500 meters as it is statutory.

Chairman, while concluding the meeting, said that the written statements have been received in the meeting and they are being handed over to the MPCB and instructed to send their answers in written form. The said written comments

will be submitted to the Government alongwith the Final Environmental Impact Assessment (EIA) report, minutes of the meeting.

Chairman, Environment Public Hearing Committee opined here that the public has no opposition to the project and development. But it is expected that their basic needs should be fulfilled, i.e. drinking water, good roads, medical facilities, education facilities. If they are not getting it, it is necessary to understand their displeasure. For this, co-operation is expected from the Project Proponent.

Chairman, Environmental Public Hearing Committee thanked all the local people, project affected persons, government officials and employees, Police Administration, project management and declared the public hearing is concluded.

Meeting ended extending thanks to the Chair.
