Project Proponent M/s N.N. Global Mercantile Pvt. Ltd., S. No. 131/2, 131/3, 131/4, Village-Muthara, Taluka-Rajura, District-Chandrapur, Maharashtra has applied to Environment, Forest & Climate Change Department (MoEF & CC) Govt. of India, (GoI), New Delhi for permission of carrying out the study in the radius of 10 k.m. of project and preparation of Environment Impact Assessment (EIA) Report for obtaining Environmental Clearance for their proposed modification in existing 2.0 MTPA Deshaled Coal Crushing Unit to 2.0 MTPA Wet Coal Washery at Survey Number 131/2, 131/3, 131/4, Village-Muthara, Taluka-Rajura, District-Chandrapur, Maharashtra

The proposed project has been approved by the MoEF & CC, GoI, New Delhi and Terms of Reference (ToR) was sanctioned on 13-11-2019. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing and to include in the final environmental impact assessment report the environmental issues raised by the project affected people about the proposed project. As the proposed project falls under Category A2 (a), it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from MoEF & CC, GOI, New Delhi.

However, as per the latest notification dated 12th April, 2022, the projects whose capacity is less than 2.5 MTPA (coal washery) will be notified under category B and the application for Environmental Clearance (EC) of the said project will be submitted to the State Environmental Impact Assessment Authority (SEIAA), Ministry of Environment & Climate Change, Govt. of Maharashtra, Mumbai.

Project Proponent Project Proponent M/s N.N. Global Mercantile Pvt. Ltd., Survey Number 131/2, 131/3, 131/4, Village-Muthara, Taluka-Rajura,

District-Chandrapur, Maharashtra has applied Maharashtra Pollution Control Board on 29/07/2022 for conducting Environment Public Hearing. District Collector, Chandrapur, Maharashtra State, in co-ordination with MPCB Chandrapur Office, approved to hold physical public hearing and online public hearing on 16/11/2022. The meeting number and password was made available.

As per EIA Notification, 2006, 30 days' advance public notice was published by Sub Regional Office, MPCB Chandrapur in the Local Newspaper in Daily Lokmat for Marathi and in National Newspaper daily The Times of India for English on 14-10-2022. An appeal is made to residents of the area, environmental organizations, residents to be displaced by the project or residents to be affected by the project in any other way to submit their views, comments, suggestions or objections about the proposed project in writing or by email to the local MPCB Chandrapur office till the date of public hearing. This office is in receipt 28 notices, complaints, statements, objections regarding the above project and the persons / concerned institutions have been informed to attend the public hearing and submit their views, opinion, suggestions or objections if any complaints, statements, objections.

The attendance sheets of the participants during the public hearing as well as the Order of the Environment Public Hearing Committee constituted by the Maharashtra Pollution Control Board are attached herewith as Annexure-I & II.

Minutes of the Environment Public Hearing:-

At the beginning of the meeting, Shri Atul Satfale, Sub Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener, Environment Public Hearing Committee welcomed Shri Vishalkumar Meshram, Additional District Magistrate, Chandrapur and Chairman, Environment Public Hearing Committee; Shri A. M. Kare, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member, Environment Public Hearing Committee, Project officials, Journalists, NGOs working in the field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized only for the local people and project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted alongwith Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment & Climate Change Ministry, Govt. of Maharashtra, Mumbai. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

With the permission of Chairman of the Environment Public Hearing Committee, Convener asked Environment Consultant to give presentation of Environment Management Plan of the proposed project.

Project Consultant informed regarding expansion of the project and Environment Management Plan in local language Marathi. Following points were explained in the meeting: -

Here, Chairman, Environment Public Hearing Committee opined that according to the suggestions and objections raised by the participants so far, it seems that the participants feel that the said Environment Public Hearing Committee or the Collector's Office will either approve the project or reject the project.

So, it is clarified here that the said Committee has only authority to conduct the public hearing. There is no right to approve the project or reject the approval of the project. The task of the Committee is to record the suggestions and objections raised by the local people in the meeting and submit the minutes to the Government. Convener, Environment Public Hearing Committee said that various suggestions, objections were raised during the meeting, The issues raised were crop damage especially in neighboring fields due to dust, rail sliding, train stopping for long time for loading, local people, school bus, ambulance taking unnecessary long time, construction of shed in crematorium, help for Hanuman temple in the village. He requested Project Proponent to give explanation regarding the same.

Project Proponent gave his name as Kushal Gupta. He started answering each and every question. He said that the company is informing about the activities planned under CSR and CER funds.

- 1) Letters have been sent to the Sarpanchs of the surrounding villages to provide information to the local people of employment in the skilled, semiskilled and unskilled cadres for the next one and a half to two years during the construction phase of the project and after the completion of the project. Apart from that, if a local person desires employment in the above cadre, he will have to bring a letter from the Sarpanch;
- 2) There is a railway siding at the back side of the company. It comes under Central Railway, Government of India. Various companies load their goods there. Now WCL has started loading their cargo. Company's loading is not even 5%-10% of WCL's loading. So WCL has 50 racks while our company has 5 racks. We have made correspondence several times with the Central Railway regarding the difficulty that the villagers are facing in reaching that side of the railway siding. But there is no response from them;
- At this time Shri Jitendra Baburao Jiwane, Police Patil objected that WCL has nothing to do with this sliding. Because WCL has independent sliding. Project Proponent are giving wrong information;
- 4) At that time project promoter Mr. Kushal Gupta said that PRPL code is available, there are two platforms available. WCL from one platform and other companies from other platforms.

At this time, Member, Environment Public Hearing Committee suggested to explain about the gate being closed. Here Project Proponent said that if the train remains standing for two hours, then we are also at a loss. We also corresponded with South Central Railway to Secunderabad. There is no response from the railway.

On this occasion, Convener expressed the opinion that the train should not stand there during school and office hours. Project Proponent further said that South-Central Railway supply the racks from Secunderabad once they become available. Railway authorities does not tell the time.

Member, expressed his opinion here that this issue of the villagers must be resolved. Senior Railway officials should be met with local people along with their Say.

At that time, he suggested to some of the participants that the company promised to build a paved road next to the company, it should be completed. If No Objection Certificate is given, road under or above the railway line can be

built, but as some villagers demanded construction of both roads (above and below) Gram Panchayat has not given No Objection Certificate.

Project Proponent informed that the point on compensation for the damage of agriculture crop is raised here.

Member here referred the demand made by the farmer of Pandhar Kavani Shri Nagurao Shankarrao Koudgave.

Project Proponent informed that we pay compensation every year. He provided a copy of it.

Shri Nagurao Shankarrao Kaudgave said that every year Rupees 80,000/- compensation is given. But there is loss of 7-8 lakh every year.

Shri Kaudgave remarked that Rupees Twenty five lakhs was received as compensation for the road, here only 80,000/- despite loss of 7-8 lakhs per year.

At that time, Project Proponent remarked that compensation is given more as the land goes forever, how will it be given for crops? But a letter should be submitted to the company regarding that, surely a way will be worked out.

Here the Chairman opined that the compensation should be increased. It cannot be kept fixed. Member asked to call a meeting of the concerned PAPs immediately and find a solution;

- The project promoter said that there was a demand to build a shed on the cremation ghat. It will definitely be provided.
- Loaders are available in the company and it will be made available. The letters are available for it;
- A green belt will be developed for disturbance caused by rack loading to railway sidings, so as not to damage the surrounding agriculture.
- 9) Convener, Environment Public Hearing Committee said that if railway sidings are receiving complaints about dust pollution, why Mist Type Fogger is not installed for it. Convener said that Mist Type Fogger is available in movable, truck mounted, tractor mounted. Convener suggested to install Mist Type Fogger on railway siding as there is transportation issue. The project promoter said that further action will be taken immediately.

- 10) Project Proponent said that if the dry washing unit is changed to wet washing, the pollution will automatically reduce.
- 11) Solar power plants will definitely be provided. At that time Mr. Nandkishore Subhash Wade, Sarpanch, Gram Panchayat Kalamna, Taluka-Rajura, District-Chandrpur said that solar energy panels are to be installed to provide electricity to the village. At that time, the promoter of the project remarked that the need of the village should be informed letter, it will definitely be considered.
- 12) As informed in the Presentation, 50-60 skilled workers will be required, the local people will be appointed. Also, in the unskilled category, local people will be given opportunity.
- 13) Project promoter said concrete road will be constructed. The company doesn't just make promises, because we have all the evidence.
- 14) Member suggested clarification regarding truck parking. The project promoter said that this national highway is going to be developed. The project is moving. For this, the boundary wall will be taken back and truck parking will be done.
- Project Proponent suggested to submit the list of skilled and unskilled local youth.
 - Chairman suggested that each village should submit its list to the company.
- 16) Project Proponent informed that the treated effluent will be recycled and reused in the process. Hence, the effluent will not enter into the nalla. Now also, it is not going into nalla.
- 17) Last year, Khamona village has demanded to conduct Medical Camp. He said that the aim is to organize a medical camp every three months.
- 18) The demands made by the Gram Panchayat will be definitely considered.

Shri Rajesh Bele demanded that if dust from the project is causing harm to children, it is your responsibility to organize children's health camps. However, how many child medical camps will be conducted every year?

At that time, the Project Proponent said that pediatricians will be called in the medical camp. Chairman suggested that as many project-affected villages as possible should be contacted and organized medical camps.

Chairman of the meeting while concluding the meeting said that today we have gathered here to conduct the Environment Public Hearing of M/s N.N. Global Mercantile Pvt. Ltd.,) Survey No.131/2, 131/3, 131/4, Village - Muthara, Taluka-Rajura, District-Chandrapur, Maharashtra for their modification in existing 2.0 MTPA Deshaled Coal Crushing Unit to 2.0 MTPA Wet Coal Washery.

This Committee is constituted to note the suggestions, objections of the local people regarding the proposed project in environmental angle only and this Committee does not have any power to sanction, recommend or reject the project.

Chairman further said that the suggestions, objections raised during the meeting have been noted and minutes of the meeting will be prepared in Marathi and English and it will be submitted alongwith Final EIA report, the written suggestions, objections through MPCB Head Office at Environment, Forest & Climate Change, Govt. of India, New Delhi. An Expert Committee will take further decision regarding this project. The copy of the minutes and video will be made available after request only.

Chairman, Environment Public Hearing Committee thanked all the local people, project affected people, government officials and employees, Police Department, all the management of the project and announced that the public hearing has been concluded.
