Public hearing for proposed sand ghats on Tapi River at Savalda, Aarale, Amalthe Tal. Nandrbar & Kouthal Tasa, Kurhawad Tasa, Tal. Shahada, of Nandurbar District conducted at Collector Office, Nandurbar on 14/02/2023 at 11:00 AM respectively. The said public hearing convened under Chairmanship of Shri. Sudhir Khande, Resident Deputy Collector (RDC) and Additional District Magistrate, Nandurbar.

Hon'ble Member Secretary, Maharashtra Pollution Control Board issued order dtd. 19/01/2023 towards constitution of panel to conduct the said public hearing having Regional Officer (RO), Maharashtra Pollution Control Board (MPCB), Nashik as member and Sub-Regional Officer (SRO), Maharashtra Pollution Control Board, Dhule as convener. Convener informed Chairman that RO, MPCB, Nashik could not attend the said public hearing due to prior engagements.

Shri. Pranav Pakhale, SRO, MPCB, Dhule and convener of public hearing welcomed Hon'ble Chairman, Shri. Deepak Chavan, District Mining Officer, Nandurbar, and all citizens.

First, of all, convener of public hearing explained that it is mandatory to obtain environmental clearance for certain type of projects according to the provisions of EIA Notification of Ministry of Environment, Forest and Climate Change dated 14/09/2006 and Amendment dated 01/12/2009 and environmental public hearing is mandatory before obtaining the environmental clearance. Project Proponent. Resident Deputy Collector, Nandurbar has submitted proposal to MPCB on 21/12/2022 along with requisite fees for conducting the environmental public hearing for proposed sand excavation activity on sand ghats of Tapi River at Savalda, Aarale, Amalthe Tal. Nandurbar & Kouthal Tasa, Kurhawad Tasa, Tal. Shahada, of Nandurbar District.

According to the application received to MPC Board for conducting public hearing the date for the public hearing is fixed as per the approval of Hon'ble District Collector, Nandurbar. 	B. Will sand extraction be done by suction pump?	B. Sand extraction will be done by conventional method (spade, shovel etc.) rather than mechanical methods such as suction pump.
	C. What measures will be taken if roads are damaged due to sand transport.	C. Part of funds will be made available under the District Mineral Foundation.
