- Mr. Babbu Khan Pathan, Social Worker, Manegaon, Teh. Ramtek, Dist. Nagpur raised the issue that:-
 - Information provided by G. D. Ispat, said information has been by them in written through an affidavit to the Government of India or the Government of Maharashtra? Has an affidavit been given?
 - Nearly 35 thousand trees will be cut in this area. It is recorded that Acharya Nagarjuna conducted Ayurvedic and chemical experiments in Ramtek taluka in history. All these experiments have been done with medicinal plants of the near by forest area. These herbs will be destroyed.
 - 35 thousand trees were going to be planted 300 km away in Yavatmal district will not benefit to this area.
 - 58 feet mine will be dug, big pumps will be installed. Due to which water level will decrease.
 - Due to mine excavation large amount of soil will be excavated where it will dump. If disposed improperly, in dams, lakes, fields, rivers drinking water will not be available.
 - Today, the constituents like carbon dioxide, magnesium oxide etc. which will go down to the ground due to dumping will contaminate the drinking water.
 - The company has denied that tiger, deer are living in this project. It is also a tiger corridor. If the tiger does not find pigs, deer, buffaloes, cows and other wild animals to eat, it will enter the village and eat the people.
 - The project will cause displacement of wild animals. Then there will be no place for them, then these wild animals will come into human settlements and human conflict will arise.
 - Only 42 people will get employment in this mine but the type of employment they will get is not given.
 - This mine is 1 km from my farm. Sometimes deer and tigers come near my farm but they

The survival of the tree will be more important than the valuation of the company.	
3	Mr. Subodh Awadhi, Vani raised the issue that:- I have been working in conservation for many years. I come from a mining affected area, due to mining the farmers will suffer. Due to mine the road in the proposed project area will damaged due to truck traffic. The dust generated from the quarry will go on the farmers' farms and & will damaged the crops. Tadoga and Tipeshwar mine quarries is near my village so wild animals come to Vani town. Due to debris of soil, the water will be blocked and the water will not drain. Due to mining, wild animals will come to the village and create conflict between human and wild animals. If there will be mine quarry, there will be an increase in crime. He requested to consider this proposed project of mine from all sides and then take the right decision.	Hon'ble chairman suggested to raised next question.
4	 Mr. Rishikesh raised the question that:- Is it correct to grant new leases where the mine is proposed and how many people are taken into trust. Another thing is that at Mansar there is a mine of MOIL which has been running for at least 150 years. What is the need for this project while it is running? In 3500 acres there is Khindsi Reservoir which receives water from the hills. This water is used by people for drinking and for agricultural crops. 	

Due to the said mine quarry, the polluted water will go to Khindsi Reservoir, so what is the planning of the project proponent. what precautions you are going to take to prevent it from going and if it goes, I want an answer on it.

5 Mr. Sanjay Zade raised the issue that :-

- The decision of committee that this mine is going to start or not, public hearing decision will you going to present to the government, if you give approval, we will not be able to do anything.
- This village is divided into two directions. One says that this mine should be started, while the other says that there will be an effect on the environment. Therefore, for the damage that will be caused in this area, which solution is prepared by company it should first follow up with each grampachayat. If there is no information about the loss or benefit due to the mining in the village, two opinions will be created. So far this has been the experience wherever the mine has been created. There people do not know what they are going to get after mining. Mining should be created here but environment should not be damaged, farmers loss. How much funding are they going to get if people are distraught if our roads are possibly damaged. Every village panchayat should be told what alternative schemes will benefit the villages affected by this mine.
- Ramtek is the most heavily mined area. The 42 people who are going to get employment in this mine. People should be informed whether they are going to be employed permanently or part-time and the nature of that work.
- 30 thousand trees will cut and plant will plant them in Yavatmal. We are not against mining but our people should get employment, our forest should be saved, roads should not be damaged, otherwise we will protest.
- This forest is made by our tribal people, this area belongs to villagers. So care should be taken not to destroy this forest. Whether you

	approve the mining or not, I know what will be the decision, but the mining should be done in a completely proper manner, if it is not done, I am expressing my opinion that the people of all the three villages will come to the streets and not allow the mining to start.	
6	Mr. Rahul Babanrao Kothekar, President of Ramtech Wild Challenger Organization, raised the issue that:-	Hon'ble chairman inquired whether there were any one from Guguldoh is present.
	• We have been working in this field since 12 years. Tiger is the main animal in this area and many other rare species of animals, birds and reptiles live here. Has the company mentioned the number of tigers in the report, there are Mogalkasa and Pench projects nearby. Once this area is declared a protected area for tigers, tourism will automatically generate employment and create many opportunities for self-employment. This area should be declared a protected area for tigers without mining here.	
	 Another issue is that the road system will deteriorate. Mining will lead to an increase in mining crime and increase in criminality. Due to the overburden from the quarry, the wind blows the dust into the surrounding area and settles on the surrounding agricultural crops and can damage the environment, causing damage to the agricultural crops. As this forest is home to various animal species, it is requested to recommend to the central government that this project should not be done and Guguldoh should be declared as a protected area for tigers.

Manganese Ore Mine, it has been mentioned that 25-30% of Manganese in this area is categorized as low grade and high grade silica core and the quality of Manganese low grade. Why should the company pursue this mine at this location and further stated that the conclusion of the research paper is that the drilling has proved that the deep extension below is very limited and the company does not know what exactly will come out in 5 years.

- Another point raised is that the document filed for Forest Clearance and Environmental Clearance we have given in the court.
- In the presentation, the company has told the information about how many people they are going to employ. Villagers want environment and employment. In the presentation, are they going to provide employment, the company said yes, they are going to hire 10 regular and 40 on contract whereas, they have shown 42 in the presentation.
- I have submitted the information in the court that according to the report of the telemetry data of the Wildlife Institute of India, Guguldoh area is a protected area for wildlife. As the tiger is deprived of prey, every day one person dies in the area where the mine is located and there is human wildlife conflict.
- There are two lakes on both sides of this mountain that lake gets its water from this mountain, that water goes to Khindsi lake through Suranadi and the water from Khindsi lake is supplied to Ramtek city. And this water is used for drinking and agriculture. Withdrawal of 3.5 KLD water per day will decrease the water table and reduce the availability of water for drinking and agriculture. And even if the 40 people you are going to employ are only for 5 years, you must understand that this environment has a huge scope.

- There is one more authority to decide on this project. These are raised by the NGO in the High Court and if the High Court grants relief, both the sides will take a unanimous decision, that decision will be binding on all of us.

- As per earlier document M/s. Shanti G. D. Steel given proposal & same was pending. According to that about 36 thousand trees were counted for trees cutting but there are more than 2 lacs trees. Not given to numbering to trees & how 35 thousand trees are counted. As proposed mine is near to the Pench project and the Nagzira project it is home of wild animals such as tigers, bears, and cheetahs.
- Government gives lease to tribals people due to which the existence of forests is destroyed and violent animals like tigers appear in their area. Government has not given agricultural lease to many tribal farmers. For government mining follow-up was no done but for private mining company much follow-up is being done. There is no point in cutting down 2 lakh old trees which are two hundred years old and planting 5 lakh new trees. About 2 lakh trees will be cut & same we can plant through MNREGA scheme from local women. It is ridiculous to cut the trees here and plant them in Yavatmal. If government mine opened here, there will be good pay, good quality health facilities and employment. See Chokhala, Kachurvahi mine where people not get employed. - Those who oppose the project are more compared to those who say the project should happen. There is not a single mine that has benefited from this type of mining. Not everything that is said about the project will be done. If these works are not done tomorrow, where we will appeal. Nearby are the quarries of Chokhada and Kiranapur, none of the said works have been properly carried out at that time. At Bhandarbodi mining has been dug up but not provided fencing yet.
