Minutes of Environmental Public Hearing of M/s Moil Limited, Pathari sand mine, Vill. Pathari, Tq. Tumsar, Dist. Bhandara, lease area 40.41 hectare expansion for sand (bajri) mining from 50,000 cumt/Year to 1,00,000 cumt/Year, conducted on 06/02/2024.TIME 01.00 P.M., At. Grampanchayat Office, Pathari, Tq. Tumsar, Dist. Bhandara.

As per Ministry of Environment and Forest, Govt. of India Notification dated 14.09.2006 amended notification dated 1.12.2009, Eenvironmental public hearing was conducted for M/s Moil Limited, for their proposed expansion of sand mining at Pathari sand mine Vill. Pathari, Tq. Tumsar, Dist. Bhandara, lease area 40.41 hectare from 50,000 cumt/Year to 1,00,000 cumt/Year under the Chairman of Shri. Darshan Nikalje, Sub Divisional Magistrate, Tumsar & Chairperson of the Public Hearing Panel. Shri. Manoj Watane, Field Officer, representative of the Regional Officer, M.P.C.Board, Nagpur was the member of the public hearing panel, and Shri. Kishor Pusadkar, Sub-Regional Officer, M.P.C.Board, Bhandara act as a convener. Public Hearing conducted on 06/02/2024, at 01.00 p.m at. Grampanchayat Office, Pathari, Tq. Tumsar,Dist. Bhandara. Shri. Anay Navandar (IAS), Sub-Divisional Officer, Mohadi also attended said public hearing. Attendance of the People present during Public Hearing is attached as (Annexure-I.)

BACKGROUND:

Proposed expansion in sand mining project attracts provisions of EIA Notification, 2006. M/s MOIL Ltd has requested Maharashtra Pollution Control Board to conduct a public hearing required for Environmental Clearance for their proposed expansion of sand mining in Pathari sand mine Vill. Pathari, tq. Tumsar, Dist. Bhandara, lease area 40.41 hectare from 50,000 cumt/Year to 1,00,000 cumt/Year vide letter dated 16.09.2023. Head Office, Maharashtra Pollution Control Board, Mumbai Vide letter no. MPCB/JD.(WPC)/ENV-PH/B-231120-FTS-0248 dated 20/11/2023 directed to initiate public hearing process.

PURPOSE AND PROCEDURE:

With permission of Chairman of Public Hearing, Sub-Regional Officer, MPCB, Bhandara & Convenor has started Public Hearing procedure by welcoming Chairman, Member of the public hearing panel, officers & public present during hearing.

Sub-Regional Officer, MPCB, Bhandara, informed that Public Hearing is conducted under provisions of the EIA Notification 2006 and amended thereof for recording views/objections/ suggestions of participants regarding proposed project, and same will be communicated to the Competent Committee. It was also clarified that this panel has not right to take any decision for accordance of any kind of approval to the project and appealed participants to express their views and suggestion orally or in writing.

Sub-Regional Officer, MPCB, Bhandara further said that notices for public hearing were published in two local widely circulated Newspapers i.e. the 'The Hitavada' (English) and 'Lokmat' (Marathi) on 04.01.2024 for thirty days period. Copies of the same are enclosed as (Annexure-II.)

Copies of Executive summary both in English and Marathi, with Environment Management Plan and other information/documents submitted by Project proponent were made available to the public by making these documents available in various Govt. offices as well as local Gram Panchayat as per MoEF GOI Notification. Suggestions, comments, and objections of the public were called in writing during the notice period of the publication of notice. The public hearing panel was constituted vide MPC Board Office Order No. E-102/2024 vide letter No. BO/JD/(WPC)/PH/B-240112-FTS-0037 dtd.12/01/2024. Copy enclosed as (Annexure-III). Hon. Collector, Bhandara vide order no. 70/2024, dt. 05/02/2024 Authorized Sub Divisional Magistrate, Tumsar as Chairman of the said Committee. (Annexure-IV).

Executive summary in English and Marathi with soft copy along with other documents were kept in the following offices for information and study of concerns and asked to give extensive publicity.

Thereafter, Sub-Regional Officer, M.P.C. Board, Bhandara and convenor of public hearing requested project proponent i.e M/s. Moil Ltd. to give detailed technical presentation on their proposed project.

Technical Consultant for M/s Moil Limited has given technical presentation for their proposed expansion of sand mining from 50,000 cubic meters/year to 1,00,000 cubic meters/year over 40.41 Hectare mining lease area w.r.t environmental aspects of proposed sand mining, mining practices, environmental management plan, occupational health and safety management, green belt development plan, made a presentation on project benefits, environmental management plancosts, etc.

After presentation, Sub-Regional Officer, M.P.C. Board, Bhandara appealed people present during hearing to raise any questions, suggestions, comments, objections regarding the said project by stating their name and village or can submit in writing as well.

During public hearing, a written statement was submitted by Sarapanch, Pathri as well as on 6/2/2024, the objection of Prakriti Foundation, Chandrapur was received through email and are enclosed herewith. (Annexure-V).
