MINUTES OF THE ENVIRONMENTAL PUBLIC HEARING FOR PROPOSED PROJECT OF DEVELOPMENT OF HARBOUR AT VILLAGE - SAKHARI NATE, TALUKA-RAJAPUR, DISTRICT - RATNAGIRI, MAHARASHTRA PROPOSED BY PROJECT PROPONENT M/S MAHARASHTRA MARITIME (MMB), **BOARD HOME** DEPARTMENT (PORT 2nd TRANSPORTATION), FLOOR, INDIAN **MERCANTILE** CHAMBERS, RAMJI KAMANI ROAD, BELLARD ESTATE, FORT, MUMBAI – 400 001, MAHARASHTRA

The Environment Public Hearing for proposed project of Development of Fisheries Harbour at Sakhari Nate, Taluka – Rajapur, District – Ratnagiri, Maharashtra proposed by Project Proponent M/s Maharashtra Maritime Board (MMB), Home Department (Port & Transportation), 2nd Floor, Indian Mercantile Chambers, Ramji Kamani Road, Bellard Estate, Fort, Mumbai – 400 001, Maharashtra was conducted on Thursday, the 14th March, 2024 at 04.00 pm at Natenagar Vidyamandir Hall, At Post – Nate, Taluka – Rajapur, District – Ratnagiri, Maharashtra.

Shri Sanjay Jirapure, Sub Regional Officer, Maharashtra Pollution Control Board, Chiplun – Additional Charge of Sub Regional Officer, Maharashtra Pollution Control Board, Ratnagiri and Convener of the Environment Public Hearing Committee welcomed Shri Chandrakant Suryawanshi, Additional District Magistrate, Ratnagiri and Chairman of the Environment Public Hearing Committee; Ms. Vaishali Mane, Sub Divisional Officer-Rajapur, Taluka-Rajapur, District-Ratnagiri; Ms. Sheetal Jadhav, Tahsildar-Rajapur, Taluka-Rajapur, District – Ratnagiri; Shri Abhaysigh Shinde Inamdar, Assistant Commissioner, Fisheries Department, Government of Maharashtra; Shri Jagannath Salunkhe, Regional Officer, Maharashtra Pollution Control Board, Kolhapur and Member, Environment Public Hearing Committee; Officials of the Project Proponent, journalists, NGOs working in the field of environment, channel representatives and local people who were present in large and with permission of Chairman, Environment Public Hearing Committee started the proceedings.

Convener, Environment Public Hearing Committee informed that as per the Environment Impact Assessment (EIA) Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, GoI) dated 14th September, 2006 as amended on 1st December, 2009 and 14th August, 2018, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification.

Convener, Environment Public Hearing Committee further informed that Maharashtra Pollution Control Board was in receipt of application from Project Proponent M/s Maharashtra Maritime Board (MMB), Home Department (Port & Transportation), 2nd Floor, Indian Mercantile Chambers, Ramji Kamani Road, Bellard Estate, Fort, Mumbai – 400 001, Maharashtra to conduct Environment Public Hearing for their proposed project of Development of Fisheries Harbour, at Sakhari Nate, Taluka – Rajapur, District – Ratnagiri, Maharashtra.

Convener further informed that proposed Project as per EIA Notification, 2006 falls under Category B 7 (E) which requires to obtain prior Environment Clearance from State Environment Impact Assessment Authority (SEIAA), Environment & Climate Change Mantralaya, Maharashtra Government, Mumbai for which prior environmental consultation is mandatory.

Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the hearing and they should know the developmental activities and Environment Management Plan of the unit.

Project Proponent had submitted online prescribed application alongwith pre-feasibility report to the State Environment Impact Assessment Authority (SEIAA), Environment & Climate Change Mantralaya, Maharashtra Government, Mumbai on 29-06-2023 and it has been considered and given online approval on 30-06-2023.

District Collector, Ratnagiri sanctioned to conduct the Physical Environment Public Hearing on Thursday, the 14th March, 2024 at 11.00 a.m., but due to certain technical issues, the Environment Public Hearing is held on 04.00 noon. After sanction District Collector, Ratnagiri to conduct the Physical Environment Public Hearing and as per the Notification dated 14-09-2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, GoI), New Delhi and subsequent amendment on 01-12-2019, Member Secretary, Maharashtra Pollution Control Board, Mumbai has constituted Environment Public Hearing Panel vide Board's

The public were appealed to send their suggestions, views, doubts or objections regarding the proposed unit.

Convener, Environment Public Hearing Committee informed that 13 suggestions/objections are received against the project.

Convener informed that an opportunity is given to all participants to raise any doubts, suggestions or objections regarding the proposed project in environmental angle, which can be submitted by orally or in writing also.

Convener asserted that this Committee is only for recording public opinion, suggestions, objections and has no right to approve, reject or recommend the project. The suggestions/objections raised by the participants in the public hearing will be noted and it will be included in the minutes of the meeting.

Similarly, the revised Environmental Impact Assessment Report of the Project Proponent should have to be submitted to SEIAA, Environment & Climate Change Department, Maharashtra Government Mumbai after taking note of the video recording of the said meeting, suggestions and objections recorded in the meeting after approval of Chairman of the Environment Public Hearing Committee through Head Office, Maharashtra Pollution Control Board. An Expert Committee there takes further decision regarding the same He requested Chairman of the Environment Public Hearing Committee to inform Project Proponent to start the presentation.

With the permission of the Chairman, the Environmental Consultant of the project made a presentation on the entire Environmental Management Plan (EMP) for the proposed project.

Environment Consultant of the project said that Sakhari Nate is a village situated on the west coast of Ratnagiri district in the Konkan division of Maharashtra and is a major fishing port with a large fishing and fish distribution business. There are about 450 fishing boats operating here and considering the large scale of fishing, infrastructure is not available to meet the needs of fishing boats and fishermen.

Local fishermen have been demanding for many years a well-equipped fishing harbor at Sakhari Nate. Therefore, the Department of Fisheries, Government of Maharashtra has prepared a proposal to develop Harne Fish Port.

Environmental Consultant informed that the project has been approved under the Government of India's Fisheries and Aquaculture Infrastructure Development Fund (FIDF) vide letter dated 22nd August, 2022.

State Environmental Impact Assessment Authority (SEIAA) of the Department of Environment and Climate Change, Government of Maharashtra has granted Coastal Regulation Zone Clearance (CRZ Clearance) to the said project on 26th September, 2023.

The fish handling capacity of the proposed fish port is 35,050.0 tonnes per annum.

Environment Consultant said that the total cost of the said project is Rs 153.47 crore and after the completion of the port with all facilities, it will be handed over to the Department of Fisheries, Government of Maharashtra.

After completion of the Presentation, Environment Public Hearing Committee appealed participants tod raise any suggestion, objections in respect of project proponent in environmental angle only. While informing, full name and address should be mentioned.

Views, questions, suggestions/objections raised during the Environment Public Hearing and the answers/promises given by the Project Proponent:-

1) Shri Amjad Borkar, Ex.Sabhapati, Sakhari Nate Society, Taluka — Rajapur, District — Ratnagiri:-

Here, Environmental Impact Assessment (EIA) Report on the proposed project is presented. All the information about the impact on the environment during the construction phase of the project and its mitigation

measures, as well as the impact on the environment and its mitigation measures after the implementation of the project have been explained to the participants.

We are all satisfied with the explanation given regarding Environmental Impact Assessment Report and Environmental Management Plan. We fully support the project. We all desire that the said project to be completed as soon as possible.

Shri Amjad Borkar further said that while considering the facilities at the port, the facilities at the port and the facilities around the port are informed here. In the said project, a platform for boating will be developed. There is also a provision to repair the fishing net. There is an auction hall in the harbour for fish auction. Parking is available for transportation. All this is given in the diagram. This is a matter of satisfaction.

However, it is being requested to Environment Public Hearing Committee that a large number of women have come here, they are fish sellers. They have no place to sell fish. However, there is a request from the women here that space should be reserved for women for selling fish at the port and it should be developed.

Project Proponent replied that a separate space has been reserved for ancillary facilities in the said project. A shed will be built for selling fish and space will be reserved for women and the earmarked space will be developed for local women fish sellers.

I am happy that environmental public hearing has been organized in front of me to start the said project. Wholeheartedly supporting this project.

said that our project is going to be built on water. However, if additional space/plot is what provision is made to required, further action will be taken only after receiving No Objection Certificate from the concerned land owners. Project Proponent assured that efforts will be made to take a positive decision in this regard at the government level.

6) Shri Faiyyaj Nalekar, Bharatiya Janata Party Taluka Rajapur Dy.Chairman:-

There is an environmental public hearing for the proposed construction of fish harbour at Mauje-Sakhri Nate, Taluka-Rajapur, District-Ratnagiri and I fully support this project. He asked fishermen present whether they support the project? All participants expressed their support by voice vote. Fishermen have been using this port since long ago and do a business of nearly 300-400 crores. After the completion of the port, the use of trucks, tempos will increase to a large extent. So, it is requested that Gunamastar Port Road and all the toll plaza can be provided with a good quality cement concrete road or some alternative roads which goes to the port.

Project Proponent said that according to the demand, a proposal will be submitted to the Government and efforts will be made to approve the road project as soon as possible.

7) Shri Nadim Abdul Razak Kanase, Sakhari Nate, Taluka – Rajapur, District - Ratnagiri:-

Our tribe is giving full support to the said project. The reason for the joy and happiness we are witnessing in the meeting is that for many years local fishermen have been suffering while fishing, small fishermen are having trouble handling small boats, big fishermen are having trouble handling big boats. The excitement is visible because the proposed project seems to relieve the daily suffering of fisherwomen.

The dream we have seen for many years is coming true. Because the small fisherman is doing his business for how to grow up, how to get work for everyone and now there is hope somewhere. So we fully support this project.

He further questioned whether the place shown for repairing the boats is plain or substantial. Similarly, the water that comes from the mountain is the drinking water of the village. It should not be damaged. Explain the planning for the same.

Project Proponent said that while preparing the plan, it is already considered that the rain water of the village is going to get together and flow in a large quantity as it is a hilly area. Hence, we planned to build open gutters. Open Gutters will be erected instead of Fiber Gutters. They will be are embedded while developing the project. They are embedded while developing the project.

Shri Kanase further remarked that just like Mumbai's local is the lifeline, similarly the fishermen community of Sakhri Nate area is the lifeline. If the boats stay there for two days, the daily local business, direct or indirect is affected. Hence, lifeline should be also good. We have expressed support for the project and are submitting a written statement on our behalf.

8) Shri Shafi Mohammad Wadkar, Chairman, Saki Naka <u>Macchimari Sahakari Society Limited, Sakhari Nate, Taluka –</u> Rajapur, District – Ratnagiri:-

Our organization has a membership of 3,500. There are 4,500 fishermen. All my members and local fishermen here are giving have full support to this project.

9) Shri Mahim Todkar, Macchimar, Sakhari Nate, Taluka – Rajapur, District – Ratnagiri:-

We have been doing fishing business in this village for several years. Lack of supportive services which requires for the fishing industry is not available here, which makes it difficult to sell fish and dispose of them in time. Hence, first of all, we thank Government for planning the proposed project.

We have set up a small factory for fish processing at this port. It has also received a loan of 20 crores from the Government. But the fish that the factory gets must be of good quality, so this port is very much needed. Hence, this port project should be completed as soon as possible.

10) <u>Ms. Gulzar Shafi Thakur, Sarpanch, Sakhari Nate, Taluka</u> – Rajapur, District – Ratnagiri -
