

MINUTES OF THE ENVIRONMENTAL PUBLIC HEARING IN RESPECT OF PROPOSED ESTABLISHMENT OF COMMON BIO-MEDICAL WASTE, TREATMENT, STORAGE & DISPOSAL FACILITY (CBMWTSDF) LOCATED AT INDUSTRIAL PLOT NO. 5, GAT NO.356 (PART), 366 (PART), 369 (PART), 370 (PART), 372 (PART), 402, 403, 404, 405, 406, 407 AND 408, AT POST – MOUJE KARANJVHIRE, TALUKA-KHED, DISTRICT-PUNE – 410 501, MAHARASHTRA BY PROJECT PROPONENT M/S LIFE SECURE ENTERPRISES, AT POST – MOUJE KARANJVHIRE, TALUKA-KHED, DISTRICT-PUNE – 410 501, MAHARASHTRA

The Environment Public Hearing in respect of proposed Establishment of **COMMON BIO-MEDICAL WASTE, TREATMENT, STORAGE & DISPOSAL FACILITY (CBMWTSDF)** located at Industrial Plot No.5, Gat No. 356 (Part), 366 (Part), 369 (Part), 370 (Part), 372 (Part), 402, 403, 404, 405, 406, 407 and 408, At Post – Mouje Karanjvhire, Taluka -Khed, District -Pune – 410 501, Maharashtra by Project Proponent M/s Life Secure Enterprises, At Post – Mouje Karanjvhire, Taluka-Khed, District-Pune – 410 501, Maharashtra was held on Friday, the 25th October, 2024 at 12.00 noon at project site At Post – Karanjvhire, Taluka-Khed, Distict – Pune – 410 501.

Shri Babasaheb Kukade, Sub Regional Officer, Pune-II, Maharashtra Pollution Control Board, Pune and Convener of the Environment Public Hearing Committee welcomed Sou. Jyoti Kadam, Additional District Magistrate, Pune and Chairperson of the Environment Public Hearing Committee; Shri Jagannath Salunkhe, Regional Officer, Maharashtra Pollution Control Board, Pune and Member of the Environment Public Hearing Committee, Environmentalists, NGOs, Journalists, Representatives of media channels and Company Officials and local people/participants who were present and with permission of Chairman, Environment Public Hearing Committee started the proceedings.

Convener, Environment Public Hearing Committee informed that as per the Environment Impact Assessment (EIA) Notification of Ministry of Environment, Forest & Climate Change, Govt. of India, (i.e. MoEF & CC, Gol) dated 14th September, 2006 as amended on 1st December, 2009, it is mandatory to conduct prior public consultation to certain projects which are covered in the schedule of the said Notification.

Convener informed that the aim of conducting prior public consultation is to make aware, local people who can be participant in the

hearing and they should know the developmental activities and Environment Management Plan of the unit.

He informed that Head Office, Maharashtra Pollution Control Board, Mumbai was in receipt of application dated 31-07-2024 from Project Proponent M/s Life Secure Enterprises, At Post – Karanjihire, Taluka – Khed, District – Pune – 410 501, Maharashtra requesting to conduct Environment Public Hearing for their proposed Establishment of **COMMON BIO-MEDICAL WASTE, TREATMENT, STORAGE & DISPOSAL FACILITY (CBMWTSDF)** located at Industrial Plot No.5, Gat No. 356 (Part), 366 (Part), 369 (Part), 370 (Part), 372 (Part), 402, 403, 404, 405, 406, 407 and 408, At Post – Mouje Karanjihire, Taluka -Khed, District -Pune – 410 501, Maharashtra.

Convener further informed that as per EIA Notification No.1533 (E), Dated 14-09-2006 and Amended Notification Dated 17-04-215, the proposed activities falls under Category B-1, Schedule 7 (DA), which requires to obtain prior Environmental Clearance from the State Level Expert Appraisal Committee (SEAC), Maharashtra and State Environment Impact Assessment Authority (SEIAA), Maharashtra for which prior environmental consultation is mandatory.

Project Proponent had submitted online prescribed application on 04-07-2024 alongwith pre-feasibility report to obtain ToR (Terms of Reference) to the State Environment Impact Assessment Authority – SEIAA, Maharashtra, Department of Environment & Climate Change, Maharashtra Government, Mumbai and it has been considered by State Environment Appraisal Committee, (SEAC), Maharashtra and granted online approval on 25-07-2024.

Accordingly, Project Proponent has appointed NABET approved Environment Consultant and through their Environment Consultant had carried detailed Environmental Survey in the radius of 10.0 k.m. of the project site to study the proposed impact on environment due to the commissioning of this project and prepared a draft Environment Impact Assessment (EIA) Report and submitted it.

Joint Director (Water Pollution Control), Maharashtra Pollution Control Board, Mumbai vide letter dated 23/08/2024 directed Sub Regional Officer, Pune-II, Maharashtra Pollution Control Board, Pune to carry the process of conducting environmental public hearing regarding the said project.

Afterwards, Sub Regional Officer, Pune-II, Maharashtra Pollution Control Board, Pune vide letter dated 13-09-2024 requested Hon. District Collector, Pune to conduct Environment Public Hearing of the respective activity.

District Collector, Pune vide letter dated 13-09-2024 directed to conduct Physical Environment Public Hearing on Friday, the 25th October, 2024 at 12.00 noon, and after getting sanction from District Collector, Pune, Member Secretary, Maharashtra Pollution Control Board, Mumbai as

per the Notification No. S.O. 1533 dated 14-09-2006 and as per Amended Notification S.O. 3067 (E) Dated 01-12-2009 as issued by Ministry of Environment, Forest & Climate Change, Govt. of India, (MoEF & CC, GoI), New Delhi has constituted Environment Public Hearing Committee vide Board's Office Order No. E- 167 of 2024 under letter no. BO/JD (WPC)/PH/B- 241023- FTS- 0086 dated 23-10-2024 as under: -

As per said Notification, 30 days' advance public notice was published by Sub Regional Officer, Pune-II, Maharashtra Pollution Control Board, Pune in the local newspaper in daily Loksatta for Marathi and in national newspaper daily Indian Express for English on 24th September, 2024. The public were appealed to send their suggestions, views, doubts or objections regarding the proposed unit.

Also copy of EIA report and executive summary were made available in Marathi and in English at various notified Government offices as under:-

Convener informed that 1 nos through e-mail suggestions / objections have been received by Sub Regional Officer, Pune-II, MPCB, Pune regarding the proposed project.

Convener informed that an opportunity is given to all participants to raise any doubts, suggestions or objections regarding the proposed project in environmental angle, which can be submitted by orally or in writing also.

Convener asserted that this Committee is only for recording public opinion, views, suggestions, objections regarding the proposed project in environmental angle only and the Committee has no right to approve, reject or recommend the project. The suggestions/objections raised by the participants in the public hearing will be noted and it will be included in the minutes of the meeting. Similarly, the revised Environmental Assessment

Report of the Project Proponent, written suggestions/objections and minutes of the meeting in Marathi and English after approval of Chairperson, Environment Public Hearing Committee will be submitted through MPCB Head Office to the State Level Expert Appraisal Committee (SEAC), Maharashtra and State Environment Impact Assessment Authority (SEIAA), Maharashtra, Ministry of Environment & Climate Change, Maharashtra Government, Mumbai after taking note of the video recording of the said meeting, suggestions and objections recorded in the meeting. An Expert Committee there takes further decision regarding the same. He requested Chairperson of the Environment Public Hearing Committee to inform Project Proponent to start the presentation.

With the permission of the Chairperson, Environmental Consultant of the project made a presentation on the entire Environmental Management Plan (EMP) for the proposed project. She said that if the bio-medical waste is not disposed of scientifically, it can be hazardous-infectious to all human beings, animals. The said project will scientifically process and dispose of bio-medical waste. The investment for the said project is 574.0 lakhs and the said project site is as per the directives passed by the Central Pollution Control Board dated 21st December, 2016.

Environment Consultant said that permission has been given to collect bio-medical waste from Maval, Khed, Junnar, Khalapur – (Khopoli-District-Raigad), Haveli, Mulshi, Shirur talukas and Dehu Road Military Cantonment area for the said project. Bio-medical waste is collected only in color-coded non-chlorinated HDPE bags, thus indirectly generating employment and source of income for the local people as such bags are used in large quantities. The said waste will be brought from the above area in closed vehicles with marking of vehicles as per the directives. Small nursing homes, clinics and other similar medical institutions providing medical services that cannot afford expensive Bio-Medical processing and handling facilities require Centralized Bio-Medical Processing and Handling Facilities, which can be set up in 75.0 km as per Bio-Medical Waste Management Rules, 2016 (Amended 2018 & 2019). If Common Bio-Medical Waste Processing Facilities are available in the periphery of 75.0 k.m., it discourages setting up of individual processing and handling facilities.

Project Consultant informed that Common Bio-Medical Waste, Treatment, Storage & Disposal Facility (CBMWTSDF) of the said Project Proponent has been functioning at MIMER, Medical College, Talegaon Dabhade, District-Pune for the past twelve years and Bio-Medical Waste

Management services are provided in Maval, Khed, Haveli, Junnar, Ambegaon and Mulshi, Shirur talukas and Khalapur- Taluka of District Raigad.

Environmental Consultant said that according to the needs of the society there has been a tremendous increase in health care facilities, biological laboratories, pathological laboratories, research laboratories and veterinary clinics in Pune and Raigad districts.

Thus, even if a Common Bio-Medical Waste, Treatment, Storage & Disposal Facility (CBMWTSDF) is operated at full efficiency of 50.0 kg per hour i.e. twenty hours per day, it is still insufficient to handle the large volume of bio-medical waste generated. Hence, there is unnecessary load on various machineries of the project and for the maintenance's sake, running of project activities have to be curtailed for few hours.

Environmental Consultant while giving detailed information about the Environmental Management Plan (EMP) of the project said that the solid hazardous waste, battery waste, e-waste coming in the project will be sent to approved recyclers for further processing.

Whereas ash, chemical sludge generated after incineration of project waste will be sent to Common Hazardous Waste, Treatment, Storage & Disposal Facility (CHWTSDF), Ranjangaon, District-Pune for further processing.

During the presentation, some of the participants came in group and handed over objection letter regarding the proposed project to Chairperson, Environmental Public Hearing Committee.

After the group left the dais, Environmental Consultant further informed that if any waste is stored for a long time, it will smell bad. However, the said waste will be processed immediately.

The working officers and employees of the project will be given training from time to time, and also they will be medically examined from time to time.

A separate Environment Management Cell will be set up in the project. Also, green belt will be developed around the project

After the Presentation -

Convener, Environment Public Hearing Committee informed that during the public hearing, written letter is received from Karanjvihire Gram Panchayat. Gram Panchayat has opposed this project. It is mentioned that this project should not be allowed to commission here.

He further informed that Maharashtra Pollution Control Board has received a letter by email today from Shri. Tanaji Divekar dtd. 25/10/2024

in which some doubts/objections regarding the feasibility of the proposed project. Environmental Consultant of the project are directed to submit written reply for the written objections to submit alongwith minutes of the meeting to submit it to Government.

Chairperson, Environmental Public Hearing Committee asked about their main objection.

Convener replied that doubts have been raised regarding the capacity of the project. Objections have been raised as whether the proposed project is economically viable?

Chairperson, Environmental Public Hearing Committee appealed all to raise any suggestions/objections in respect of proposed project in environmental angle only.

Convener, Environment Public Hearing Committee also appealed that while asking questions, full name and residential address should be informed.

Views, questions, suggestions/objections raised during the Environmental Public Hearing and the answers/promises given by the Project Proponent/ Project Environment Consultant / Environmental Public Hearing Committee :-

1) Shri Santosh Margaj, Residence -Karanjivhire, Taluka – Khed, District – Pune :-

He took the mike in his hand and stood up to speak.

At that time, Chairperson, Environment Public Hearing Committee said that there is an objection that Bio-Medical Waste brought here from the city will cause problems/nuisance to the villagers in the area. Hence, an explanation in detail should be given as to what measures are going to be taken to avoid any threat to the environment due to the said bio-medical waste. For example, as mentioned in the presentation, any waste that smells, you are going to dispose of the waste in the project itself. Therefore, local people/participants who are attending this meeting should be given a complete explanation of any possible side effects, health problems, and what measures the company is going to take in this regard in the vicinity of the project.

Environmental Consultant while explaining again informed that what is special about this project is that the waste coming in the project is not just waste, but it is Bio-Medical Waste. This waste will be generated only in clinics and hospitals. Plastic bags of specific color are provided in clinics and hospitals. The waste is to be brought in a closed vehicle only

as specified. The collected Bio-Medical Waste will not be dumped or thrown anywhere, it will come in this center here. The Bio-Medical Waste will be scientifically disposed of within this center only. Yellow, Red, Blue and White coloured waste bags/dust bins will be kept in the health center itself. This will be filled in plastic bags and brought to the center in closed vehicles only. Bringing from any other vehicles is prohibited. Incinerable Bio-medical waste after bringing it will be incinerated. Biomedical waste incineration does not cause any air pollution. The ash generated after incineration of waste will be sent to the Common Hazardous Waste Treatment, Storage and Disposal Facility (CHWTSDF) at Ranjangaon center for further processing.

Environment Consultant said that local people fear that the process will cause air pollution. Venturi scrubber, the most advanced device will be installed here for air pollution control and chimney/stack of 30.0 Meter height will be erected in the project. Smoke which will be generated out of the chimney will not contain any dust particles.

Environmental Consultant informed that the main source of noise pollution in the project is Incinerator and DG set. DG set will be used in case of power failure only. Noise pollution control system will be installed in the project, hence there will be no noise nuisance to the villagers in the area. Effluent Treatment Plant with the capacity of 25.0 KLPD will be operated within the project itself to treat the effluent generated in the project. Treated effluent will be recycled and reused in the process. Treated effluent will not be generated outside the factory. This project is ZLD – Zero Liquid Discharge project.

2) Shri Arjun Supekar, Residence – Karanjivihire, Taluka – Khed, District – Pune :-

Information regarding the smell nuisance generation in the project should be given to all.

Environmental Consultant replied that the local people are worried about the smell nuisance from the project. Odour management in the project will be carried in two phases.

First, the transportation of Bio-Medical Waste will be carried only in closed vehicles as specified. All those vehicles are leak proof which means there will not be any type of leakage from those vehicles

Also, training will be extended to Attendants / Helpers to handle the Bio-Medical Waste. Similarly, training will also be provided for collection of Bio-Medical Waste. The collected Bio-Medical Waste will be processed

within 48 hours only. Bio-Medical Waste will not be kept more than 48 hours in the project. So, there will not be any smell nuisance from the project. Hence, there will not be any sufferings due to smell nuisance.

Green belt will be developed at all sides in the project. Also, the project will be strictly follow regarding fresh air and cleanliness. Therefore, the residents of the area will not have any problem of bad smell.

3) Shri Jagannath Salunkhe, Member, Environment Public Hearing Committee And Regional Officer, Maharashtra Pollution Control Board, Pune :-

Wind direction at the project site, water slope – The slope of the effluent generated in the project is at the river side. The wind which will blow, it will blow towards the village. Hence, although Bio-Medical Waste will not remain for more than 48 hours, there is still concern among local people. For that, the prescribed standards need to be made more stringent. On one side is nature-river, while project waste water will go towards the river. People are afraid of this. The question of the local people is what measures Project Proponent will take in this regard. It is necessary to take strict action in this regard.

The second point is technical. There are 600.0 kg/hr projects which are in operation in Pune and Pimpri Chinchwad areas, even though, Project Proponent has planned this project. So, have you completed the Gap Analysis study in this regard? These technical issues should be taken into consideration, so that the fear among the local people can be removed.

Environment Consultant replied that Gap Analysis study has been conducted. Therefore, the details of bio-medical waste are shown in the presentation

The number of non-bedded facility/centers and number of bedded centers in health care facility in our jurisdiction at Maval taluka, Khed taluka, Haveli taluka was studied. There are 8,955.0 beds in the Bedded Medical Service Centre. So, the incineration waste generated from those beds is considered as 270.0 grams per day per bed. And the total Bio-Medical Waste that will be generated from the health center alone in our area of operation is going to be 2.42 MT/day. The rest of the Bio-Medical Waste will be 4.67 MT/day.

4) Shri Uttam Bajare, Residence – Karanjvihire, Taluka – Khed, District – Pune :-

Information should be given regarding the method of disposal of waste water generated in the project.

Project Proponent answered that Industrial Effluent generated in the project will be treated at the Industrial Effluent Treatment Plant (ETP) and the treated effluent will be recycled and reused in the project itself. This Project is a Zero Liquid Discharge (ZLD) project and not a single drop of treated effluent will be discharged from the project. Here, the industrial waste water quantity is considered more than the present discharge of industrial effluent.

Also, rain water has also been considered. ETP will not be affected by rainwater. Industrial Effluent Treatment Plant (ETP) will be commissioned inside of the project. Rainwater will not affect it. Rain water harvesting will be properly planned.

At that time, Shri. Bazare asked how plan will be made? Project Proponent said that the excess rain water will be collected in the tank and will be released to the river.

Here, Environmental Consultant replied that the rain water which will fall in the project site will be harvested on the rooftop and the surface harvesting which will fall on the ground will be stored at one place through channels and pipelines. The estimated rainwater is measured and a storage tank of higher capacity will be commissioned within the project itself. It will be used for green belt development in the project. No water will go out of the project.

5) Shri Santosh Kolekar, Local Residence, Taluka -Khed, District - Pune :-

While starting a company in the area, Management of that respective company was saying that the water from the project will not be released. This time it rained so much that even an automatic bike could not go.

But if the waste water from this proposed company if gets mixed with rain water, our agriculture fields at the downside of this areas will be completely destroyed. There are our domestic animals on the farm. Now the river water is as clear as glass, we can drink it. Also, the smoke which will be released from this project will also have adverse effects in this area. Considering all these things, local people here are protesting against the commissioning of this project.

Convener, Environmental Public Hearing Committee assured to take appropriate action against the concerned company.

6) Shri Santosh Margaj, At Post – Karanjvihire, Taluka – Khed, District – Pune :-

A farmer's agriculture field is at downside of that company. His farm was damaged during the rainy season. Nothing gets after the damage. If any opposition is done, then only some benefits will get. Here, all our villagers are against this project. Villagers of all the villages in this area will be made aware regarding this proposed project. All citizens of this area are strongly against this project. We will oppose this project forever

Convener, Environment Public Hearing Committee on behalf of Chairperson, Environment Public Hearing Committee informed that Project Environment Consultant of the Project Proponent should arrange a meeting of the villages who have raised objections in writing and should give them detailed information regarding the proposed project. Hence misunderstanding regarding the proposed project will be cleared. Meeting should be arranged at Gram Panchayat Office.

Convener, Environment Public Hearing Committee again appealed all the participants to raise their views, suggestions or objections in respect of proposed project in environmental angle only. If anybody desires to submit written suggestions/objections, acknowledgement will be given.

After waiting for few minutes, Convener, Environment Public Hearing Committee again appealed all the participants to raise their views, suggestions or objections in respect of proposed project. There was response from the participants.

Convener, Environment Public Hearing Committee while concluding the meeting thanked all participants for attending the meeting. He informed that in the meeting villagers of Karanjvihire has expressed their opposition against this proposed project. It is noted.

Convener, Environment Public Hearing Committee further said that as per suggestions of Hon. Chairperson, Environment Public Hearing


Committee, experts from the Environmental Consultant's Organization should inform the villagers detailed project. This will help to remove their objections and doubts
