Chandrapur, Maharashtra has applied to Environment, Forest & Climate Change Department (MOEF&CC) Govt. of India, (GOI), New Delhi for permission of carrying out the study in the radius of 10 k.m. of project and preparation of Environment Impact Assessment (EIA) Report for obtaining Environmental Clearance for the Proposed Expansion of Limestone Production Capacity from 2.0 Million TPA to 3.5 million TPA, Top Soil 0.25 Million TPA, Waste (OB/IB)-2.40 Million TPA, Sub Grade 0.50 Million TPA (Total Excavation 6.65 Million TPA) along with existing crusher of 1200 TPH in Maratha Limestone Mine-II, (ML Area-880.31 Ha) in villages Bakhardi, Upparwahi, Chandur, Pimpalgaon, Lakhmapur & Thutra, (Tehsil: Korpana) & Sonapur (Tehsil: Rajura), Dist. Chandrapur, Maharashtra.

The MOEF&CC, GOI, New Delhi approved Terms of Reference (TOR) was sanctioned on 12/05/2022. As per Environmental Impact Assessment Notification, 2006, the environment study should be carried in the radius of 10 km from the project site before environmental public hearing and to include in the final environmental impact assessment report. As the proposed project falls under Category A-1 (a), it is mandatory to the Project Proponent to obtain prior Environment Clearance (EC) from MOEF&CC, GOI, New Delhi.

Project Proponent M/s. Ambuja Cements Ltd., Maratha Cement Works, Po. Upparwahi, Tal. Korpana, Dist. Chandrapur, Maharashtra has applied to Maharashtra Pollution Control Board on 25/10/2024 for conducting Environmental Public Hearing. District Collector, Chandrapur, Maharashtra State, in co-ordination with MPCB Chandrapur Office, approved to hold a

public hearing on 03/02/2025. MINUTES OF PUBLIC HEARING:-

At the beginning of the meeting, Shri Umashankar Bhadule, Sub-Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Convener, Environment Public Hearing Committee welcomed Shri. D. S. Kumbhar, Additional District Magistrate, Chandrapur and Chairman, Environment Public Hearing Committee; Shri Tanaji Yadav, Regional Officer, Maharashtra Pollution Control Board, Chandrapur and Member, Environment

Public Hearing Committee, Convenor, Environment Public Hearing & Sub-Regional Officer, Maharashtra Pollution Control Board, Chandrapur, Project officials, Journalists, NGOs working in the field of environment and local people who were present in large number and informed all the procedure of the public hearing. He appealed all the participants to raise views, doubts, ideas, suggestions or objections regarding the proposed project in environmental angle only. He said that the public hearing is organized only for the local people and project affected persons, so that the environmental issues and doubts would be resolved.

Convener of the meeting further informed that this meeting is arranged to know the feelings, suggestions or objections of the local people for the proposed project in environmental angle only and this Committee has no right to sanction, reject or recommend the proposed project. The suggestions or objections received during the meeting will be noted and it will be included in the minutes of the meeting in Marathi and in English and it will be submitted along with Final EIA report, the written suggestions/objections with the approval of Chairman of the Environment Public Hearing Committee through MPCB Head Office to Environment, Forest & Climate Change Ministry, Govt. of India, New Delhi. An Expert Committee will take further decision accordingly.

Convener of the meeting further informed that as per the provisions of the Notification, the meeting is being photographed and video is being shot and after the presentation, the participants can raise their questions, suggestions, thoughts and objections. The Project Environmental Consultant or Project Proponent will answer the same. While asking questions, first inform your full name and residence village.

control measures is not given during presentation. The farmers are not given compensation for their crop loss due to air pollution from mineral transportation. The villagers are filing complaints to Hon'ble District Collector, but no action is being initiated. The shed installed during the last public hearing had flown but still environmental clearance was granted to that project. We strongly oppose the Public Hearing. If the Environmental clearance is granted to the project then we will ask the court the intervene.

The land area of that lease was 579.90 Ha. No expansion is done for that project. The Public Hearing is conducted for expansion of the existing project. encroachment. The issues raised during the last Public Hearing are not answered till date. Nowadays employment is not available, if the employment is available then the person is transferred to other location, denying that leads to VRS. This is a serious issue. The company has not provided employment to the people whose land is acquired since last 20 years. Employment shall be given to them. The doubts found in the EIA report are not rectified by any company. MPCB has installed AAQM station on the building of Gadchandur Municipal Council. Nobody is seen operating the said machine, but the readings are displayed on the website of MPCB. If the said readings are incorporated in the EIA report, then it is misleading the local people. There is an issue of parking in Transport Nagar, but the company has not taken any measures. The mine pit near Thutra village is not closed which is leading to death of many people.
