The Environment Public Hearing for proposed manufacturing of Ethyl Acetate Facility of Capacity 65 MT/Day Proponent M/s. Pro Gro Bio Pvt Ltd, Gat No.158, Shiv Patti, Near Piyush Sugar Factory, At Post – Tandali Wadgaon, Tal. & Dist. Ahilyanagar, Maharashtra was conducted on Wednesday, the 30<sup>th</sup> April, 2025 at 11.00 noon at project site.

Ahilyanagar, Maharashtra.

Views, questions, suggestions/objections raised during the Environmental Public Hearing and the answers/promises given by the Project Proponent/Project Environment Consultant / Environmental Public Hearing Committee:-

## 1) Shri. Abhilash Raosaheb Ghige, R/o Tandali Wadgaon, Taluka & District Ahilyanagar-

He expressed his gratitude for the information provided by the organizer and environmental consultant regarding this project. He expressed his gratitude to Mr. Sanjay Ambole Patil, sir, for the fact that the project will generate some employment in the village. It was suggested and expected that the CSR fund that will be received through this company should be spent more and more on the social work of this village.

## 2) Shri. Sunanda Reddy, Environmentalist, Chairman, Dharitri Paryavarn Parikshan Sanstha, District Nalgonda, Telangana State -

Namaskar, me Sunanda Reddy, the Environmentalist. My best wishes to management for this new project. I am the first environmentalist to support this. In my opinion unemployment is the major pollution at this stage in India. All the state government & central government provide approximately 5 to 6 lacs jobs every year. Approximately 1 crore people come to market for employment, the remaining 95 lac people depending on the industrial sector for their jobs. In this context I am requesting MPCB to give their unconditional permission to this industry. In this environmental fact is tree plantation. Whatever plantation 33% is government norms. But the project proponent has promised 35% plantation. It is congratulating to management. In this small suggestion instead of normal plants plant fruit bearing plants medicinal plants. It is very good & useful for the environment & also rainwater harvesting is important. Approximately 2 to 4 mm of rainwater received in every year please use this rainwater harvesting is precaution as its very useful for developing ground water level. Use CSR funds for this expenditure. Also I am congratulating the management for employment your investment is 12 crore you are giving direct employment to 25 indirect employment approximately 100 distant indirect employment to 150 to 200 it's a very incredible to management, here I am telling you just recently I have attended public hearing of NTPC whereas for every 33 crores of investment providing one job. And also is there any possibility that government give the skill training to workers who utilizes it in any other works. Finally congratulating your consultancy for details work has done. Finally requesting MPCB to give unconditional permissions to this industry. Thanking you for this opportunity.

## 3) Shri Vyankatesh, Environmentalist on NGO -

Respected sir everybody is good morning. My name is Vyankatesh one of the Environmentalist. Actually I appreciate project proponent why I appreciate is given employment to 25 members & to give priority to local people & education wise difficult category employment criteria administration & technical. Hon. Chairman, Environmental Public Hearing Committee instructed the Environmental Advisor to provide clarification on the objections raised in the meeting.

The environmental consultant replied that the public present at the environmental public hearing was assured that the CSR fund available to the project beneficiaries would be allocated according to their needs in consultation with the local gram panchayat, and that trees would be planted on both sides of the road adjacent to the company premises, which would help reduce noise pollution from vehicles.

Also, photos and video recordings of the said public hearing will be submitted to the government for further action.
