Maharashtra State Road Development Corporation has proposed expressway of Pavnar (District Wardha) to Patradevi (District Sindhudurg) at Maharashtra-Goa Border-Super Communication Maharashtra Shaktipeeth Expressway-Package-II (Nanded, Hingoli, Beed, Latur, Parbhani and Dharashiv) total length 267.480 Km in the state of Maharashtra in which 66.39 Km part of this expressway is proposed in Parbhani District. The Public Hearing is proposed to be conducted from environmental angle about the said project as per the EIA notification No. S.O. 1533 dated 14.09.2006 (as amended on 01.12.2009) issued by MoEF, Govt. of India.
