Subject: Assessment of Polluted River Stretches of 5 States with regard to the Hon'ble NGT matter OA No. 673/2018

In the 1st meeting of the Central Monitoring Committee (constituted by Hon'ble NGT in the matter OA No. 673 of 2018) held on 8th January 2020 under the Chairmanship of Secretary, DoWR, RD & GR, Ministry of Jal Shakti, it was decided that for States having more number of polluted stretches, a group of officials from NMCG, NRCD and CPCB may visit and review the status of pollution (domestic and industrial), available sewage infrastructure and existing/futuristic gap to make a conditional assessment and requiring interventions, if any.
