ORDER

Sub: Assigning the areas of operation of Common Hazardous Waste Collection, Treatment, Storage and Disposal Facilities in the State of Maharashtra for Management of Hazardous Wastes.

In compliance of the sub rule 2 of Rule 5 of the Hazardous Waste (Management & Handling) Rules 1989, as amended 2003, the jurisdiction and operational area for each of the Common Hazardous Waste Collection, Treatment, Storage and Disposal Facilities (CHWTSDf) is assigned as under:

Note:

1. This order shall be effective from its date of issue.
2. The previous order dated 20.10.2005 is hereby revoked.
3. The area / jurisdiction allotted earlier and mentioned in the consent/ Authorization granted to CHWTSDF operators is hereby rescinded.
4. All CHWTSDF operators shall follow this order from its commencement.
5. The areas for proposed CHWTSD facilities at Shendre and Mahad shall be allocated after the commencement of the facilities.
6. The Incinerable hazardous waste from operators MEPL and VEPL above shall be stored upto the quantities mentioned into the consents to operate granted to them upto commissioning of the Incinerators as per the Hazardous Waste (M&H) Rules, 1989 as amended and guidelines issued by CPCB. Excess quantity shall be sent to M/s MWML, Taloja for incineration.
7. Industries pertaining to buffer zone are permitted to obtain membership from both or either of the nearby disposal facilities and they may send hazardous waste to any of one CHWTSDF.
