

TERMS OF REFERENCE

The Consent Appraisal Committee (CAC) shall consider applications for consents/authorizations under Water (P&CP) Act, 1974, Air (P&CP) Act, 1981 and Hazardous Wastes (M & H) Rules, 1989 as under.

- 'RED' category : Projects with capital investment above Rs. 15 crores.
- 'ORANGE' category : Projects with capital investment above Rs. 100 crores.
- 'GREEN' category : All project beyond Rs. 500 crores/ All A & B class Municipal Councils and Corporations.
