CIRCULAR

Sub : Compliance of various Orders/Judgments passed by the Hon'ble National Green Tribunal, Western Zone Bench, Pune

The Hon'ble National Green Tribunal, Western Zone, Pune has passed various Orders/Judgments in various NGT matters for necessary compliance in a time bound.


The Board has already issued various circulars from time to time regarding compliance of the Orders/Judgments passed by the Hon'ble NGT within the stipulated time.

In this regard, Mrs. Supriya Dangare, Panel Advocate vide e.mail dtd.5/8/2016 informed that the Hon'ble NGT would like to file the Affidavit on the compliance of the directions issued by the Hon'ble NGT within the stipulated time and if the compliance is not done in stipulated time, the Hon'ble Tribunal will proceed accordingly, which may include contempt proceeding and the Hon'ble NGT will not entertain the Execution proceeding as Original Application.

It has been noticed that the filing of an Affidavit before the Hon'ble NGT, Pune are often delayed due to transfer of responsibility from the area Co-coordinator to subject expert. As a result, it is not prepared properly & filing of an Affidavit before the Hon'ble NGT, Pune is delayed.

Therefore, all the Area Co-Ordinators/Regional Officers/Sub-Regional Officers are instructed to submit the compliance of the directions issued by the Hon'ble NGT within the stipulated period in a tabular form of the directions issued by the Hon'ble NGT in its Judgment.

In case, the casual approach is adopted in compliance of the Judgment/Orders passed by the Hon'ble NGT in a time bound manner, the concerned Area Co-Ordinator and concerned Regional Officer/Sub-Regional Officer will be jointly and severally held responsible, for further necessary action and non-compliance of the directions issued by the Hon'ble NGT, Pune as well as any adverse order passed or being passed by the Hon'ble NGT. However, it is the overall responsibility of the Area Co-Ordinator to comply with the Orders/Judgments passed by the Hon'ble NGT within stipulated period, which please note seriously.
