In order to ease the permission procedure, as a part of "Ease of Doing Business", the Hon'ble Principal Secretary and the Chairman of the Board convened the meeting on 16/04/2015, wherein, decision was taken to reduce one step in the process of grant of consent to establish, first consent to operate and registration for recycler/re-processor of the hazardous waste listed in schedule IV as per the rules 8(1) & 9 of Hazardous Waste Rules 2008 and E-Waste dismantler/re-cycler as per rule 11 of E-Waste Rules 2011.

Therefore all Regional Officer/Sub-Regional officers are hereby, directed to obtain application for grant of first C to O and application for registration at a time from the project proponent and process both the application simultaneously for recycler/reprocessor of HW Waste listed in schedule IV as per the rules 8(1) & 9 of Hazardous Waste Rules 2008and E-Waste dismantler/re-cycler as per rule 11 of E-Waste Rules 2011. Consent to first operate and registration shall be granted at a time as per delegation of powers.

A list of documents required for obtaining Consent/Authorization/Registration for Hazardous waste recycling/re-processors and e-waste dismantler/recyclers hazardous waste listed in schedule IV as per the rules 8(1) & 9 of Hazardous Waste Rules 2008 and E-Waste dismantler/re-cycler as per rule 11 of E-Waste Rules 2011 respectively are enclosed herewith.
