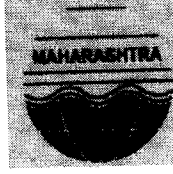

CIRCULAR

Sub: - Sampling & compliance report in-respect of Sugar & Co-gen industries fall in R-I & R-II category in coming season.

Ref: - Circular issued regarding verification protocol of sugar industries vide dtd. 21.07.2014.

You are aware that Board has prepared the verification protocol for sugar industries to verify the compliance of consent conditions/CREP guidelines. The verification protocol has been communicated to all RO's and SRO's vide e-mail dtd. 21.07.2014 also hosted on the web site of the Board.

As per the decision of CAC meeting held on 17.06.2014 Board had issued Directions to the sugar industries which are comes under the purview of CAC vide dtd. 20.06.2014, and based on the compliance report as per verification protocol submitted by the concern SROs, the Renewal of Consent has been issued as per the policy decided in the CAC meeting held on 07.10.2014.


In continuation to this SRO's are directed to give visit program to the Field Officers to visit the sugar industries (List of R-I & R-II categories is annexed) in their jurisdiction & check the following points regarding compliance—

- 1) Verify the compliance made by the sugar industries as per verification protocol.
- 2) Collect the JVS samples on monthly basis to confirm the ETP up-gradation and as well as scientific operation of the same.
- 3) Compliance to be verified in-respect of "reduction in waste water generation to 100 litres per ton of cane crushed" as per the proposal submitted by industry and now compliance made by them as per the procedure given in a verification protocol and also on the basis of physical verification of flow meter reading.

The details of 1st visit report and confirmation of JVS sample collection shall be done and communicated to compliance cell on or before 25.11.2014. The JVS results shall be separately communicated to Compliance cell on or before 15th December 2014. For the subsequent months (Dec. 14, Jan. 15, Feb. 15; March 15 & April 15) the visit report and confirmation of sample collected shall be intimated by 10th of the every months & JVS results analysed shall be communicated by 30th of that month.

The samples should be submitted to the respective Laboratories for priority analysis with quotation 'CAC-SUGAR-SAMPLE'.
