**OFFICE ORDER NO. 68 OF 2008**

Sub: Payment of professional charges bills of  
Panel Advocates

The Board in its 118<sup>th</sup> meeting held on 20/11/1997 had approved the scheme in respect of appointment of Advocate and professional charges to be paid to them. The Chairman and Member Secretary of the Board were authorized to appoint 'A' Panel as 'B' Panel Advocates as well as senior counsel for High Court matters and Advocates on record and Senior Counsels for Supreme Court matters.

The Sr. Law Officers had been authorized to appoint "B" Panel Advocates for High Court matters and Advocates upto Dist level Courts vide office order No. E-11 of 2003. A copy of the order is enclosed for your ready reference.

Now, it has been decided to delegate the powers to Sr. Law Officer (Policy & Law Division) to sanction payment of professional charges bill for 'B' Panel Advocates appearing before the High Court and Advocates appearing upto the District level Courts as well as quasi judicial forums.
