**Ref:** EIA Notification dt. 14/09/2006 and amended Notification dt. 01/12/2009.



Public Hearing Panel in accordance with the Notification issued by MOEF, GOI vide letter dt. 14.09.2006 and as amended on 01.12.2009 is formed & Environmental public hearing is conducted under chairmanship of District Magistrate or his representative not below the Rank of an Additional District Magistrate.

The Panel order is issued with approval & signature of Member secretary of MPC Board. However, for issuing panel order & to simplify the process.

Hereafter, the office order for proposed public hearing will be signed by concern HOD & concern HOD should take approval monthly from Member Secretary.



The approval of issued panel office orders may be taken monthly.


