Board has issued the consent to manufacturing and compressing various gases viz Air, Nitrogen, Oxygen, Argon, Carbon dioxide, Medical Oxygen, Helium, Nitrous Oxides & Dissolved Acetylene under "RED" Category.

Gas Manufacturer's Society Mumbai vide letter dated 13.7.2010 has submitted the representation for change in the category of such type of industry from "RED" to GREEN" as there is no use of water in the process hence no waste water generation from process. Water is used as make up water for cooling of compressor etc.

As per CPCB guidelines for management of consent, Industrial gases namely; Air, Nitrogen, Oxygen, Argon, Carbon dioxide, Helium, Nitrous Oxides are comes under the "Green "Category except Medical Oxygen & Dissolved Acetylene.

Member Secretary has accorded the approval for change in category of manufacturing and compressing various gases viz Air, Nitrogen, Oxygen, Argon, Carbon dioxide, Medical Oxygen, Helium, Nitrous Oxides from "RED" category to "Green" Category except Dissolved Acetylene subject to condition that the unit shall not generate any trade effluent (even by the washing of cylinder activity), Hazardous waste and air emission.
