
STANDING ORDER

TOWHOMSOEVER IT MAY CONCERN

This Standing Order is hereby issued on behalf of the Maharashtra Pollution Control Board in respect of NOCs / Letters issued by the Regional Officer/s / Sub-Regional Officer/s, granting permission for trading activities, which states that since no manufacturing activity involved, the consent for trading is not required from the Maharashtra Pollution Control Board and further states that for trading of any of hazardous waste, the unit shall obtain authorization from the competent authorities as per the Hazardous Waste (Management & Handling) Rules, 1989, as amended from time to time.

Such NOCs/ Letters have created unnecessary confusion as if these are consent/s of the Board to these trading activities and thereby, some of the traders have unnecessarily involved in these activities in violation of the provisions of the Environmental Laws.

In view of the above facts and circumstances, MPCB hereby withdraws all such NOCs/Letters issued by the Regional Officer/s / Sub-Regional Officer/s, giving NOCs to the trading activities, stating that consent for trading activities is not required, but, it should apply for authorization, in case, it involved in trading of any type of hazardous waste. Henceforth, such type of NOCs / Letters should not be relied upon by any person for the purpose of any transaction. A sample copy of NOC/Letter issued by the then Regional Officer-Mumbai vide letter NO.ROM/TB/212, dtd.4/2/2003 to M/s.Ankit Enterprise, 7/1 Hari Om Compound, Opp.Jangaleshwar Mahadev Mandir, JMM Road, Asalfa, Ghatkopar (West), Mumbai-84 is enclosed for ready reference, so as to treat it as non-applicable and non-enforceable.
