

**MINUTES OF MEETING RIVER REJUVENATION OF POLLUTED RIVER
STRETCHES AS PER THE HON'BLE NGT ORDER DATED 08/04/2019 CONDUCTED
ON 09/07/2019 AT 02.15 p.M. IN THE MEETING HALL OF REGIONAL OFFICE,
MPCB, AURANGABAD.**

A meeting regarding River Rejuvenation of Polluted River Stretches as per the Hon'ble NGT order dated 08/04/2019 was conducted on 09/07/2019 at 02.15 p.m. in the Meeting Hall of Regional Office, MPCB, Aurangabad.

Shri A.D. Mohekar, Regional Officer, MPCB, Aurangabad welcomed all those present during the meeting and started the proceeding of said meeting.

Shri Mohekar taken the review of earlier meeting conducted on 03/01/2019 and asked about the status of long term and short terms measures taken/to be taken by the local bodies to clean river as discussed in the said meeting.

Latur City Municipal Corporation :

Shri K.A. Bamankar, Executive Engineer, Latur City Municipal Corporation reported that the Latur City Municipal Corporation has proposed to provided 2 Nos. of Sewage Treatment Plants (STP) having capacity of 32 MLD & 40 MLD for which required DPR has already been sanctioned. He further stated that work order for construction of STPs will be placed within 30 days and both the STPs will be commissioned before April, 2021. Shri Mohekar asked about budgetary provision for the same, upon which Shri Bamankar reported that the total budget is of Rs. 139 Cr. for which the Corporation has received the administrative and financial approval for which the funding will be as Central Government – 50%, State Government – 25% & Latur City Municipal Corporation – 25%.. Shri Mohekar further asked about the treatment and disposal of sewage effluent generated from Corporation area. Shri Bamankar informed that the Corporation will adopt SBR technology for the treatment of sewage effluent and will achieve the BOD as 5

mg/l at the outlet of STP and the treated effluent will be used for irrigation purpose. Further, He further informed that the Corporation has prepared and submitted DPR for the utilization of treated effluent on land for irrigation for which they have appointed a agency namely M/s. Clean Aqua. Shri Mohekar informed him to submit a time bound proposal for the installation of both the STPs alongwith designed parameters for outlet of STPs.

Beed Municipal Council :

Shri Mohekar asked about the sewage generation, treatment and disposal as well as short term and long term measures taken/to be taken by Beed Municipal Council. Shri B.U. Bighot, I/c Chief Officer, Municipal Council, Beed informed that the sewage generation from Beed Municipal Council area is 22 MLD for which they have proposed to provide 35 MLD capacity of STP for which administrative and financial approval is already received. Shri Mohekar asked about budgetary provision for the same, upon which Shri Bighot reported that the total budget is of Rs. 165.18 Cr. for which the funding will be as Central Government – 50%, State Government – 25% & Beed Municipal Council – 25%. He further informed that DPR has been prepared, work order is placed and the construction work of STP is in progress. Shri Mohekar further asked about the treatment and disposal of sewage effluent generated from Beed Municipal Council area. Shri Bighot informed that the Council will adopt SBR technology for the treatment of sewage effluent and will achieve the BOD as 5 mg/l at the outlet of STP and the treated effluent will be used for irrigation purpose. Shri Mohekar informed to submit Bar Chart for the compliance of the same upto April, 2021.

Paithan Municipal Council :

Shri A.D. Mohekar asked about the status of Municipal Council, but the Chief Officer of Paithan Municipal Council was not present during the meeting, hence Shri Mohekar showed displeasure and instructed to issue a letter to the Chief Officer in this matter. Shri A.G. Gojre, Clerk from Paithan Municipal Council reported that the sewage generation from Paithan Municipal Council is 2.0 MLD for which they have proposed to provide STP of 7.5 MLD capacity, the budget for the same is Rs. 46.32 Cr. Shri Mohekar informed to submit Bar Chart for the compliance of the same upto April, 2021. The officials present during the meeting requested to call the representative from MJP for the next meeting as certain issues related with STP are concerned with them.

The meeting is ended with vote of thanks to the Chair.
