4. **In Tender Document section 11 COMPLETION (GCC CLAUSE 23) (Page no 118)** The Contractor shall complete all the Works up to installation and commissioning of MCAAQMV's within **180 days** after the date of opening of Letter of Credit (LC).
 - ✓ **Kindly read as** "The Contractor shall complete all the Works up to installation and commissioning of MCAAQMV's within **one hundred and twenty (120) days** after the date of opening of Letter of Credit (LC)."




5. In Tender Document section 4.5 Validity of Bid (Page no 25) The bid shall remain valid and binding on the Bidder for **one hundred and twenty (120) days** from the final time and date for submission of the Bid. Bid validity for a shorter period shall be rejected by the Board as non-responsive.
