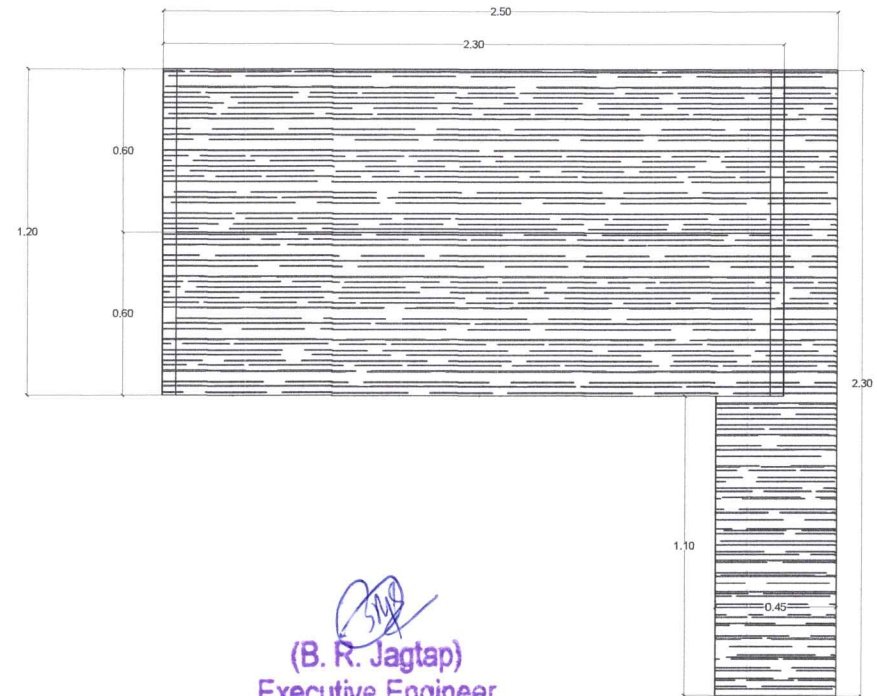
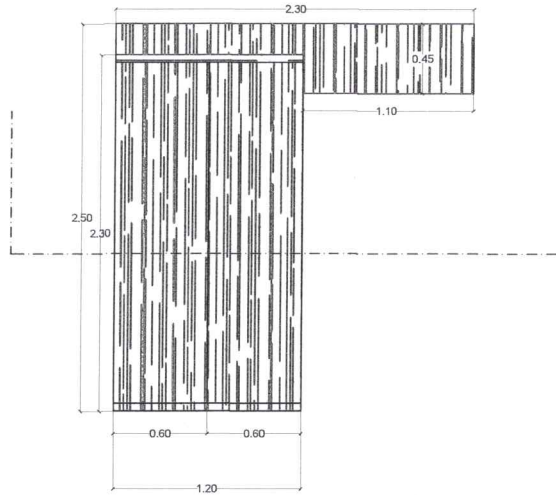
SECTIONAL ELEVATION
