Annexure 2 - Bus Chassis Specifications

The vehicle models suitable for this tender should meet the following specifications:

1. Gross Vehicle Weight (GVW) between 8 to 9 tons.
2. Wheelbase between 4000 mm to 4500 mm.
3. Overall length between 8000mm to 9000mm.
4. The overhang of the vehicle shall not exceed 60% of the wheelbase.
5. The vehicle shall comply with the specifications mandated by the Central Motor Vehicle Rules 1989.
6. Suggested model make: Ashok Leyland Ecomet / The Tata Ultra 912 / BharatBenz 914R / Equivalent
7. Front & Rear Suspension: Parabolic / pneumatic suspension
8. Engine: BS6 OBD 2 / equivalent
9. Engine Displacement: 3300 CC minimum
10. Fuel Injection: common rail diesel injection
