## Circular

**Sub: - Standardization of Membership Certificate to be issued by Common Bio Medical Waste Treatment Facility in the State of Maharashtra.**

It is responsibility of every Common Biomedical Waste Treatment Facility to issue Membership Certificate to each member Health Care Establishment (HCE) upon verification of requisite information. However, MPCB noticed that there is no uniformity in format of Certificate issued by BMW CTF in the State, which makes it difficult to MPCB officials to verify essential information of Health Care Establishments.

In View of this, MPC Board decided to bring uniformity in Membership Certificate format to be issued by Common Bio Medical Waste Treatment Facility to its registered Health Care Establishments. Certificate issued by CTFs shall have two QR codes (Online & Offline) and shall contain the information as stated. CTF shall update data/information regularly on its server for online verification of certificate.

All Common Bio Medical Waste Treatment Facilities are hereby directed to issue uniform membership certificate (**Sample Copy Enclosed**) to each registered member HCE at no additional cost. CTF operator shall ensure issue of fresh Membership Certificate to all Member HCES within 3 months with a copy to Sub Regional Office and EIC, MPCB through e-mail ([eic@mpcb.gov.in](mailto:eic@mpcb.gov.in)).
